Such are some of the revolutions that the works of time, in its rapid course, has wrought. Four years ago he made no men and their positions. Never did the world move faster than it has with us since 1860.—Springfield Republican.

The Prospect for Canada.

The spring of 1865 is opening auspiciously. The favorable weather, which the farmer has had since the 1st of May, has been well rewarded. The fall wheat, by this time, is most promising, and the spring crops, so far as can be judged of at this early stage, will be quite as good. Considering the state already made, it is very likely that the harvest will be better than we have had for many years past. In an agricultural country like this the great desideratum is a good harvest. This has been the case for some years past. The want of it, for some years, has proved this; for, with the scanty return of the field, trade languished, money became scarce, debts remained unpaid, and distress and discontent to some extent took the place of comfort and happiness. In the abnormal state of things which has existed on this continent during the past four years, another grand desideratum, to wit, the re-establishment of peace, this too, has now been secured, and we may, therefore, very fairly look upon 1865 as a turning point in our condition—the commencement of a new period of prosperity.

That the war in the United States injuriously affected Canada is beyond question. We might assume that this prior to the trade between our neighbors and ourselves being of such a kind as required a state of peace in order to be healthy and prosperous. And we know, as a matter of fact, that the drain upon their resources for war purposes, the engaging in military pursuits of thousands of their able-bodied men, the depreciation of the currency and the general insecurity felt on both sides, all tended to unsettle and lessen the business done. This was the case as between Canada and the United States. Another phase of evil, however, may be designated as purely internal. In view of the fact that the Canadians have been backward in making these improvements and engaging in those enterprises which a state of peace would have warranted, and which the advancement of the Province demanded. Farmers would not clear new lands, nor manufacturers erect new mills; rural and manufacturing operations were bated, bakers fought shy when any scheme out of the common routine was hinted at. Foreigners who had large investments in the Province embraced every favorable opportunity of withdrawing their funds to a quieter neighborhood, and those here who were spared money were anxious to get out of the country, and would have kept it beyond their control for any length of time. Hence the unprecedented deposits in the banks and other large moneyed institutions. It is said that about twenty seven millions of dollars have thus been locked up—some recoverable on demand, the rest at short notice, except the exceedingly ridiculous costumes before-mentioned, was anywhere seen. The entertainment, it is believed, was quite impromptu, the whole having been got up in an hour or so, and we feel convinced that another year Innisville will hold a prominent place among other towns and villages, whose inhabitants, by the bye, might breathe the prayer, "God save our gracious Queen."
