Synopsis of Canadian North-West.

HOMESTEAD REGULATIONS

ANY even-numbered section of a Dominion Lands in Manitoba, Saskatchewan, and Alberta, excepting 8 and 26, not reserved, may be homesteaded by any personally, of any manitopic of the personally, of any manitopic to the extent of onsequenter section of 169 sacres, more or less.

Application for entry must be made in person by the applicant at a Dominion Lands Agency or Sub-Agency for the district in which the land is situate. Entry by proxy may, however, be made at any Agency on certain conditions by the father, mother, son, daughter, brother, or sister of an intending homesteader.

DUTIES — (1) At least six months' residence upon and cultivation of the land in each year for three years.

(2) A homesteader may, if he so desires, perform the required restlence duties by living on farming land owned solely by him, not less than eighty (8) acres in extent, in the vicinity of his homestead. He may also do so by living with father or mother, on certain conditions, Joint ownership in land will not meet this requirement.

(3) A homesteader intending to perform his residence duties in accordance with the above while living with parents or on farming land owned by himself, must notify the azent for the district of such intention.
