

CHALMERS' ON THE MOUNTAIN.

CONGREGATION MAY AMALGAMATE WITH BARTON CHURCH.

Committee Appointed to Deal With the Matter—Interesting Reports Presented—Presbyterianism Booming in Upper Hamilton—Officers Elected.

The third annual congregational meeting of Chalmers' Presbyterian Church, at Mount Hamilton, East Hamilton Inc., was held last evening, and was well attended. Rev. S. S. Kirkland, moderator of the church, presided, and Mr. David Smith acted as secretary. The reports all indicated growth and prosperity. The first report was that of the Session, presented by Mr. J. R. Cook, interim clerk of the Session. The report stated that since Mr. Kirkland had left the church, the Session had been faithfully and conscientiously conducting the church's affairs, and that the church was in a healthy condition. The Session also reported that it had received a letter from the Barton Church, suggesting an amalgamation of the two churches. The Session has appointed a committee to deal with this matter.

The Managers' report stated that during the year the church debt had been reduced \$550, with interest to Sept. 1, 1907, leaving a balance due of \$600. A fence had been erected behind and on one side of the church property. Since the beginning of November the student's salary had been increased to \$8 per week; from that time up to the end of the year the average weekly collection was \$9.75; during this year it had been about \$8.75. This is accounted for by the unseasonable weather principally. The board is anxious that more of the members should adopt the envelope system. The year ended with a balance of \$108.79. The treasurer's annual statement was read by Mr. Peter Smith, and was as follows:

Ottawa, Jan. 21.—The House of Commons to-night discussed the question raised by a motion made by Mr. Ames the other day for the production of some original documents in the Department of the Interior, which he was not allowed to see there, and which motion the Government declined to accede to unless the gentleman named gave reasons for his request to see the papers. The Government to-night maintained this attitude.

Mr. Borden, who opened the discussion with an amendment to the motion to go into supply, criticized the Government for their attitude in declining to accede to the request of the people's representatives in Parliament assembled to be informed of everything necessary to explain the policy and proceedings of the Government, and for that purpose to have an opportunity of seeing and examining all documents connected with the transaction of public business, and the denial of such right by the Government justifies the refusal by this House of further supplies to the Crown.

Sir Wilfrid Laurier had no objection whatever to the motion. No one would deny the rights of members of Parliament in the matter, and he could not agree that any member has been refused his privilege. Certain rules, however, had to be followed in the public interests, and in order to insure the proper working of the departments. A member desiring to have the original document brought down should state the reason on which his motion was founded. This had not been done by Mr. Ames, though he had been asked to do it. The hon. member had distinctly stated that his motion had been framed with a view to testing the right of members to see original documents, but he had not taken the necessary and proper steps to get the original documents on which his motion was based. The moment Mr. Ames gave reasons for the production of those documents they would be produced. This was Sir Wilfrid's contention, the right course for the hon. gentleman to take. In support of this the Prime Minister quoted authoritative English authorities, showing that it was clearly laid down by the most eminent English Parliamentarians that in such cases the mover should state the reasons on which his motion is founded, in order that the House might judge as to the expediency of complying with it. That was the position of the Government, and from it they would not recede. For that reason, he repeated he agreed to the motion.

Mr. Foster characterized the Premier's speech as a nimble exhibition of climbing down from the attitude previously taken in the matter.

Mr. Oliver defended the stand taken by himself, showing that he was practicing a well-established rule in his department before the present Government came into power. He cited an instance, two years ago, in which on request of Mr. Foster, some documents had come from his department and had not yet been returned.

Mr. Foster, amid laughter on the Government side, promised to try and find and return these papers.

Messrs. Chisholm, Ross (Yale-Cariboo), Northrup, Macdonnell and Boyce took part in the discussion.

The motion, having been accepted by the Government, was carried without a division.

HAS 500 WIVES.

WITZHOFF, WORLD'S CHAMPION BIGAMIST, HELD IN ENGLAND.

Has a Chicago Career—Lovingmaking for Revenue Reduced to Science, According to Story of His Exploits.

New York, Jan. 21.—George A. Witzhoff, the world's champion bigamist, who is credited with having 500 wives, is believed to be under arrest at Bristol, England. Reports from the police of that city say that his prisoner gives the name of Arthur Hynes, but his description and career fit those of Witzhoff. Hynes or Witzhoff was arrested on a charge of matrimonial frauds. He is wanted in many cities in the United States, scores of women being complainants.

The prisoner has the same hypnotic eyes, the same German parentage, and the same knowledge of chemistry as Witzhoff. His matrimonial advertisements are worded "no triflers need apply." His arrest was brought about by a Bristol young woman who answered one of his advertisements and then loaned him \$400.

Witzhoff married a number of Chicago women before he left the United States.

Matrimonial Exploits Remarkable.
Witzhoff is declared by those who are familiar with his exploits to be the most remarkable bigamist that ever lived. His knowledge of women, his shrewdness, his cunning, and his slipperiness, the lovingmaking of the unlamented Johann Hoch was a cumbersome and awkward effort. Hoch spent the best years of his life in the accumulation of fifty wives, while his distinguished contemporary seems to have been able to increase his list of better halves at the rate of two or three a week at the rate of two or three a week with the Chicago bigamist, the lovingmaking of Witzhoff was directed toward the savings accounts of the women he married, and once their money was transferred from their keeping into his own the much married dentist sought greener pastures.

Witzhoff came to America from Switzerland over ten years ago. For a while he maintained a dental office in Detroit, and met his first difficulty when the American Dental Association found that he was practicing without a license. His action was pointed out to the executive board of the association, and he was fined \$500 and warned not to repeat the offense. After paying his fine and promising to secure a license Witzhoff left Detroit, and it is now supposed he then reached the conclusion that the marrying business offered quicker and more substantial returns than that of the dentist. He turned to his old trade of bigamism.

First Exposure in New York.
His first exposure came after his marriage to Mrs. Philip Parkhill, of New York City. Mrs. Parkhill, a tall, handsome woman, met the dentist shortly after she was divorced from her first husband, and at the end of a few days' courtship they were married. Mrs. Parkhill had a son, Herbert, and it was while the boy's teeth were being treated in a dental parlor on West Forty-second street, where Witzhoff was employed, that she first was attracted by the striking and apparently refined bigamist.

Soon after he had won her acquaintance Dr. Witzhoff told Mrs. Parkhill that he was a dentist of ability and experience, and that he was working in the Forty-second street office, and that he had no money to establish a place of his own. Believing him sincere, Mrs. Parkhill allowed him to make love to her, and within less than two weeks after they had first met the pair were married.

Witzhoff then went to Mrs. Parkhill's father, who lived in Sayville, L. I., in an effort to borrow \$3,000 with which to open an office in Bridgeport, Conn. Failing to get the money, he sent his wife on the same quest, and her visit proved successful.
