A SUCCESSFUL EXHIBITION SEEN AT BRIDGETOWN.

Annapolis and Kings Favored by Delightful Weather.

A Brief Sketch of Some of the Exhibits.

The Annapolis and Kings County Exhibition for 1903 is now a thing of the past, and "Success" may be written in large letters over all its departments.

It is somewhat of a surprise to many that a fair in these days could be made a success without the usual adjuncts that have become a marked feature of such events.

This will supply to those interested all particulars of the result of the competitive side of the exhibition. As regards the exhibits from the two counties, the excellent exhibit of Kings Co. was put on by a few farmers who made a large number of entries.

In this display there were 2500 plates of fruit. The exhibit in pears and plums was good, that of peaches scarcely up to last year's show at Kentville. W. K. Starr had an interesting display of Virginia apples.

The large exhibit of maize, rye, and buckwheat that adorned the walls added greatly in beautifying the main department of the exhibition building.

The department of high art was exceedingly well filled. Misses Blanche Murdoch, and Miss Emily Ervin and Mrs. (Dr.) M. F. Armstrong being the principal exhibitors in landscapes and Mr. J. L. Chesley of Kingston, in portraits. The latter was granted a diploma for the excellence of his work.

Local and Special News.

The Thanksgiving supper in Lawrencetown for the 15th inst. has been postponed.

The body of Mr. Peter Havel, who died in Rollinville, Mass., on Wednesday, was brought to Digby and taken to Waterford, Digby Co., for interment. The deceased was a brother of B. Havel, lately of this town.

The net proceeds of the lunch counter organized by the ladies of St. James' church last week amounted to eighty dollars and thirty-five cents. This will form a good nucleus for the new furnace fund, for which the effort was made.

The young people of this valley are not slow to know a good thing. That they appreciate a good business training is manifested by the fact that five are now in attendance at the Maritime Business College, Halifax, viz: Margaret A. —J. J. McManus, timekeeper for M. J. O'Brien, has been here for the past week collecting the tools and implements in use on the M. & V. B. Ry. last year and shipping them to Ontonagon, Ontario, now carrying on operations. A few of the scrapers were purchased by McKenzie & Mann, who are now pushing the work of construction between here and Middleton.

The St. John Sun says: "Rev. Mr. Roach, the energetic pastor of the Tabernacle Church, Haymarket Square will, it is believed, be called to the pulpit of Main St. Baptist Church. The church is a large one, but the Rev. Mr. Roach is a vigorous young man, an able preacher, and one acquainted with the local conditions. His acceptance of the call would be popular in the north end."

The attention of the Monitor has lately been called to the damage done by men and boys who loaf outside store doors and hack away the casings of the doors and window frames with their jack knives. One store in particular has its front badly disfigured and the proprietor is thoroughly aroused. With the assistance of the town's policemen he should have no trouble in bringing the vandals to book.

Judge Meagher, of the Nova Scotia Supreme Court, has retained Messrs. Buelke, Ritchie & Chisholm to institute proceedings against the Canada Law Times for publishing an alleged libelous and slanderous article at the time of the Convention of the Maritime Provinces Board of Trade meeting at Sydney, when it is alleged the judge made ungentlemanly remarks towards the delegates to the convention.

A Thanksgiving service will be held in the church at Clarence on Thursday evening, Oct. 15th. Address on "readings and music will comprise the entertainment of the evening, while the opening of the envelopes will be interesting. No people have more to be thankful for than the good people of Clarence. It is expected, therefore, that the proceeds will pay off the debt of the repairs to the church, amounting to about \$130.

To-morrow (Thursday) being Thanksgiving Day, there will be divine service in St. James Church at 10.30 a. m., consisting of morning prayer, sermon and holy communion. The sermon will be preached by the Archdeacon of Nova Scotia, Ven. J. A. Kaulbach, D. D. The sacrament of baptism will be administered at 3 p. m. At 7.30 p. m. there will be evening prayer and sermon at St. Mary's, Bellisle. Collections at morning and evening service for Clergy, Widows and Orphan's Fund.

—W. V. Brown, who invented an apple-packing box, and received a patent for the same, shipped some apples by the first shipment that went. They were the Emperor variety, and each one was wrapped in tissue paper. They averaged 1½ lb per box. Each box will hold one dozen of a barrel of apples. The returns quoted would show the average price received to be 31¢ per barrel, equal in Canadian money to \$7.56. This apple-box evidently means money for the farmer.

By the explosion of a boiler in the basement of the new P. O. building at Springhill Mines on Oct. 13th, Samuel McDowell, janitor of the building, was instantly killed, and Frederick Eaton, unskilled at Amber, terribly injured. His assistant, a boy who was standing in the doorway, was also cut and bruised and rendered unconscious. The building was badly shattered. The accident, it is thought was caused by a scarcity of water in one of the boilers used for generating steam to heat the building.

A runaway occurred on Queen street Friday, which by the merest good fortune, terminated without serious accident. A strange horse driven by Wm. Jackson, driver for the St. James Hotel, bolted when coming through the bridge and ran up Queen street thoroughly unmanageable. The driver, however, was able to guide it into the stable yard, at the Grand Hotel, where it was brought to a standstill. Miss Bent, who was in the team at the time, was thrown out and slightly cut in the face. Beyond this and a shaking up she escaped unharmed.

A successful concert was given at the Court House on Thursday evening last week for the benefit of the Baptist Church Organ Fund. A very pleasing program was rendered, which was participated in by Misses Lydia Murray, and Jessie Beckwith and Mr. Allen, of Middleton; vocal soloists, Mrs. Harlow and Miss Carolyn Piper, readers, and Miss Hetty Jackson, pianist and accompanist. Every number was well rendered and the reformer received a well merited encore. The dramatic sketch by Mrs. Harlow and Miss Murray was very amusing and performed in a most creditable manner. The stage was tastefully furnished and made an attractive setting. The audience filled the hall and about seventy dollars was received in admission fees. The Organ Fund has now grown to the respectable sum of \$2650.

In the Supreme Court held in Annapolis last week, Mr. Justice Cashew presiding, the following causes were disposed of: Huntley vs. Smith, a claim for payment of \$150 alleged to be due for a balance of the purchase money of an orchard of apples, jury failed to agree; King vs. Reese, horse-stealing, defendant acquitted; Burrell vs. Suter, an action for damages for slander, the jury found a verdict for the plaintiff with damages fixed at \$500; Kaiser vs. Slaughterhouse, an action for trespass and assault, verdict for plaintiff with \$50 damages.
