- 4. Each Contracting Government shall have the right to demand the revision of the minimum nomenclature in force. The request shall be addressed to the French Covernment, which will be addressed. to the French Government, which will thereupon convene a conference of the Contracting Governments to consider the recommendations and to draft the modifications.
- 5. Modifications of the minimum nomenclature which have been adopted at least one clear year before the next ensuing revision date at a conference convened under the preceding paragraph by a majority of not less than four fifths of the delegator of the Country of the delegator of the Country of the delegator of the Country of the C fifths of the delegates of the Contracting Governments shall take effect as from such revision data. ## ARTICLE 5
