

The Order being read for the consideration of the Business of Supply;

Pursuant to Standing Order 58, Mr. Carter, seconded by Mr. Munro (Esquimalt-Saanich), moved,—That this House declares that Canada has a special right to manage and harvest the living resources on and over its continental shelf and slope and must act immediately to assert her right to manage and control those resources.

And debate arising thereon;

Mr. Leggatt, seconded by Mr. Knowles (Winnipeg North Centre), moved in amendment thereto,—That the motion be amended by inserting therein, immediately after the word "slope", the following words:

"or to the extent of a two hundred mile economic zone, whichever is the greater,".

A Message was received from the Senate informing this House that the Senate had passed the following Bill to which the concurrence of this House is desired:

Bill S-26, An Act respecting Alliance Security & Investigation, Ltd.—*Mr. Blais*.

The Bill was deemed to have been read the first time and ordered for a second reading at the next sitting of the House, pursuant to Standing Order 100(2).

Bill C-32, An Act to impose a charge on the export of crude oil and certain petroleum products, to provide compensation for certain petroleum costs and to regulate the price of Canadian crude oil and natural gas in inter-provincial and export trade.—Chapter No. 47.

Bill C-47, An Act to amend the Judges Act and certain other Acts for related purposes and in respect of the re-constitution of the Supreme Courts of Newfoundland and Prince Edward Island.—Chapter No. 48.

Bill C-5, An Act to establish the Canadian Radio-television and Telecommunications Commission, to amend the Broadcasting Act and other Acts in consequence thereof and to enact other consequential provisions.—Chapter No. 49.

Bill C-33, An Act respecting the export from Canada of cultural property and the import into Canada of cultural property illegally exported from foreign states.—Chapter No. 50.

Bill C-13, An Act to amend the Northern Canada Power Commission Act.—Chapter No. 51.

Bill S-20, An Act to amend the Territorial Lands Act.—Chapter No. 52.

Bill C-3, An Act to amend the British North America Acts, 1867 to 1975.—Chapter No. 53.

Bill C-19, An Act to provide for payments in respect of wheat produced and sold in Canada for human consumption in Canada.—Chapter No. 54.

Bill C-37, An Act to provide for the control of dumping of wastes and other substances in the ocean.—Chapter No. 55.

Bill C-24, An Act to amend the Salaries Act.—Chapter No. 56.
