3. Is it the intention of the government to make any change in the duty in the near future on above piping?

4. If so, is it the intention to increase or to

decrease the duty?

Hon. WM. PATERSON (Minister of Customs).

1. The duty on butt and lap welded tubing from the United States is as follows :

(a). Two inches or less in diameter 35 per cent ad valorem:

(b). Over two inches in diameter 15 per

cent ad valorem;

(c). Not less than 2½ inches in diameter, when imported for mining purposes, free.

2. Dutiable tubing imported from United States for fiscal year ended June 30, 1905 was as follows :-

The amount of free tubing for mining purposes is not classified by itself in the statistical returns.

Hon. WM. PATERSON (Minister of Customs):

1. Customs officers make inspection of wire fencing on importation into Canada, for the purpose of determining its tariff rating and its valuation for duty purposes.

2. The Customs inspection does not relate to quality and grade of fencing, further than to compare the fencing with the descriptions on invoice and appraise the value of the goods and classify same for duty purposes.
