VANCOUVER—REPORTED LOADING OF WHEAT IN UNCLEAN SHIP

On the orders of the day:

Mr. Harold E. Winch (Vancouver East): Mr. Speaker, I should like to direct a question to the Minister of Transport. I am sorry I could not give him longer notice, but only about two hours ago I had occasion to send him a copy of a telegram addressed to me which stated that a shipment of wheat for the order of the people's republic of China is today being loaded in a ship at Vancouver which has not been cleaned. Fuel oil is at the bottom of the ship. I have in mind criticisms made a year ago regarding certain shipments of wheat. I would ask the minister whether he has been able to investigate the truth or otherwise of this allegation.

Hon. Leon Balcer (Minister of Transport): Mr. Speaker, I certainly will, and will ascertain that ships leaving Vancouver are properly cleaned to carry good Canadian wheat.

SHIPPIGAN ISLAND—INSTALLATION OF MARINE AID STATION

Mr. H. J. Robichaud (Gloucester): May I ask the Minister of Transport if he is now in a position to reply to the question I asked him on Thursday, February 16, with regard to the installation of a Decca station on Shippegan island?

Hon. Leon Balcer (Minister of Transport): Yes, Mr. Speaker. In the light of the additional information the hon. member was good enough to give me regarding this question about a project for Shippigan island, I was able to make wider inquiries in the department.

I am now able to advise that we are planning to instal a Decca station on this island. The survey of the site has now been completed, and we are working on plans and specifications for the station, which will form part of what will be known as the Anticosti Decca chain. Funds have been included in the 1961-1962 estimates, and the target date for operation is the late fall of this year.
