2. Has the total grant for the current fiscal year been paid?

3. If not, how much of it has been paid, and when will the balance be paid?

Mr. Green: 1. \$12,000.

2. No.

3. \$11,000. The balance will be paid as soon as parliament grants full supply.

UNITED NATIONS INFORMATION CENTRE IN CANADA

Question No. 1,220-Mr. Turner:

Is there an information centre office of the United Nations in Canada and, if not, has Canada ever applied to the United Nations to open such an office in Canada?

Mr. Green: There is no information centre office of the United Nations in Canada. The office of the Queen's printer under an understanding reached with the United Nations acts as exclusive agent for the distribution of United Nations publications in Canada. In view of this mutually satisfactory arrangement Canada has not asked the United Nations to open an information centre office in this country.

*HOSPITAL INSURANCE PLAN, B.C.

Question No. 1,223-Mr. McPhillips:

1. Has the government of the province of British Columbia sought to take greater advantage of the terms of the federal Hospital Insurance and Diagnostic Services Act in order that B.C. residents temporarily absent from the province for a period of longer than three months may continue to receive hospital benefits under the provincial plan in the event of emergency?

2. Under present arrangements, would a B.C. resident incurring hospital bills outside his home province after more than three months absence be personally responsible for all such bills?

3. What limitations are imposed by other provinces on out of province benefits?

Mrs. Casselman: 1. No. The British Columbia government has at no time sought to take greater advantage of the federal act so as to provide insurance benefits to residents temporarily absent from the province for a period in excess of three months. The hardships imposed on residents of British Columbia through this restriction have been brought to the attention of the British Columbia authorities on a number of occasions.

- 2. Yes. Unless the British Columbia resident enters the hospital during the first three months of temporary absence, he loses his entitlement and is himself responsible for the payment of hospital services.
- 3. Although there is a varied pattern of out of province benefits from province to province, all provinces with the exception of British Columbia provide insured services for

residents temporarily absent from the province during a period of one year, subject to the payment of the premium or tax in premium provinces.
