ARDA PROJECTS, NEW BRUNSWICK

Question No. 1,212—Mr. Flemming (Victoria-Carleton):

1. What are the details concerning the following ARDA projects in New Brunswick: 4001—Advisory services to farmers in farm woodlot management; 4002—Soil and water conservation, under the New Brunswick land improvement program to promote the development of agriculture in those areas where a good potential for development exists within delineated pilot areas during 1962-63; 4004—Alternate land use, acquisition of marginal land for forestry purposes at Lincour and the re-establishment of 15 families; 4005—Soil and water conservation, under the New Brunswick land improvement program, as outlined in project 4002, within delineated pilot areas during 1963-64?

2. What is the estimated cost of each project?

Mr. Sauv : 1. Project No. 4001: To provide an advisory service to farmers to assist them in the management planning, planting and thinning woodlots, the construction of access trails and other woodlot extension services.

Project No. 4002: To promote the development of agriculture where a good potential for development exists in the areas of Madawaska, Victoria, Carleton, York, Queens, Kings, Westmorland, Albert and Kent counties.

To provide assistance in solving major problems of soil and water conservation as they exist in each area.

Project No. 4004: The purpose of this project is to adjust the land use in the settlement of Lincour from combined farming and forestry to forestry exclusively and to relocate the residents in the area.

Project No. 4005: To promote assistance in the protection of land against erosion by water, the improvement of poorly drained areas by the installation of drainage systems both tile and open ditch systems. The construction of farm ponds for stock watering, fire protection and irrigation.

The areas involved in this project are the same as outlined in project No. 4002.
