SHIPMENT OF POTASH TO U.S.

Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, the Minister of Industry, Trade and Commerce wishes to inform the hon. member that the government is in a continuing process of communication with the United Kingdom about the possible effects on Canadian trade if the United Kingdom were to become a member of the EEC. In the context of negotiations which have yet to commence, the hon, member will appreciate that it would be contrary to the Canadian interest to make public the information which has been provided in confidence to the British authorities. Accordingly, the minister would ask the hon. member to withdraw his motion.
