# CONSTITUTIONALITY OF PROPOSED NEWSPAPER REGULATING LEGISLATION

Hon. Perrin Beatty (Wellington-Dufferin-Simcoe): Madam Speaker, my question is directed to one of the Government leftfielders, the Minister of State for Multiculturalism, who has been waging a one-man war on Canada's newspaper industry.

#### An Hon. Member: You are away out in left field.

**Mr. Beatty:** If the Minister's colleague will let me finish, in view of the fact that within the past two weeks the Minister was reported to have made another speech in which he said that he would be tabling legislation in the House before the end of the month to regulate the newspaper industry, will he tell the House whether he has asked for and received a legal opinion on the constitutionality of what he is doing? If so, will he table that opinion in the House of Commons at the same time the Bill is introduced?

Hon. Jim Fleming (Minister of State (Multiculturalism)): Madam Speaker, I have not said nor read anywhere where I was reported to have said that I would table the Bill in the House. I said that I hoped to have drafted legislation ready by the end of this month. I still have that hope. Although I might not make that deadline, I hope I will.

As to constitutionality, the advice of the Department of Justice, which I take as a Minister, is that our proposal will be quite within constitutional parameters.
