I am now referring specifically to the coal car contract. Could that not have been considered, and could it still not be under consideration by the Minister?

Hon. Jean-Luc Pepin (Minister of Transport): Madam Speaker, it was indeed studied as a possibility but we thought the way I indicated was a better way. As a matter of fact my hon. friend is probably not totally informed about the Transcona facility. Transcona has been in the business of building all kinds of cars in the past. It has all the facilities and it has 400 employees to keep at work. That is why a Solomon's judgment was made on the way we divided the coal cars and hopper car orders, and the way the hopper car order was divided between the three traditional suppliers.
