An Act to amend the Act of incorporation of the Seventh-day Adventist Church in Canada (Senator Frith)

First reading, May 23, 1991. Second reading and referral to Legal and Constitutional Affairs Committee, May 30. Report from Committee (with one amendment), June 18. Adoption of Report and third reading, June 19. Passed by the Commons, October 23. Royal Assent, October 29.

BILL S-4

An Act to amend the Act of incorporation of the University of Emmanuel College (Senator Buckwold)

First reading, May 29, 1991. Second reading and referral to Legal and Constitutional Affairs Committee, May 30. Report from Committee (without amendment), June 18. Third reading, June 19. Passed by the Commons, October 1. Royal Assent, October 2.

BILL S-6

An Act to amend the Act of incorporation of Metropolitan General Insurance Company in order to authorize its continuance under the laws of the Province of Quebec (Senator Sylvain)

First reading, June 16, 1992. Second reading and referral to Legal and Constitutional Affairs Committee, June 18. Report from Committee (without amendment) and third reading, June 19. Passed by the Commons, June 22. Royal Assent, June 23.
