A DOUBLE LIFE. A FORMER CANADIAN PASTOR ABANDONED IN CHICAGO FOR BIGAMY.

He is Rev. Fred T. McLeod, formerly a Congregational Minister at Kennebunk, Me.

Chicago, Oct. 1.—A Canadian pastor's double life was brought to light by the police last night.

The Rev. Fred T. McLeod walked the floor of a hall in the police station last night, being detained on charges of bigamy.

In another cell was his alleged wife with his babe in her arms.

Mr. and Mrs. McLeod were arrested at their home on warrants sworn out by Mrs. Mary McLeod of Central Kennebunk, N. S.

The complainant said the Rev. McLeod married her while he was pastor of the Congregational church at Central Kennebunk.

He was driven out of the town long after this she said "on account of his family matter and came to Chicago.

He has been here for two years but I did not hear of his second marriage until recently. I, at once, came from Nova Scotia and had warrants for his arrest sworn out.

McLeod refused to make any statement.

THE NEGRO SUBSTITUTION. Negroes Kill Four Men—Lives of Others Saved by Men from N. S. "Fireward."

Baltimore Md. October 1st.—Particulars of the riot at Naxos on the morning of the 14th of Sept. have been received by the Naxos Phosphate Company from Superintendent Smith.

On the morning of the 14th the negroes in instruction and killed four officers, namely Thomas N. Foster, George F. James, James and William T. Shea.

They then bombarded the officers and the men's quarters with dynamite and their lives were only saved after a hard struggle by the officers, and men from the British gun boat Forward.

No cause is given for the insurrection.

THE RAILROADS. Intolerable. Receipts and Expenses of the Pacific Roads—New York Correspondent.

Washington, October 1st.—H. R. A. Tamm, Commissioner of the Interior, filed with the secretary of the interior the annual report of the operations of the government for the year ended June 30th, 1889.

The commissioner discusses the railroad situation in the west and northwest and makes some suggestions as to existing evils and their remedies.

The statement of the Union Pacific Road shows a liability to the government to be \$51,200,792; total liabilities of the company, \$225,230,139; total assets, \$275,204,725; total earnings for the year ending June 30th, \$17,149,170; total expenses, \$12,922,831; net earnings, \$5,126,339.

Of this there was paid to the government \$1,644,314, or 25 per cent. of the net earnings.

The total debt of the Central Pacific June 30th, 1889, was \$125,250,365; assets \$222,757,262; total earnings, \$5,126,339; total expenses \$7,653,915; net earnings, \$1,544,333. Of this amount \$467,217 is due the government.

In his report the commissioner severely criticizes the repeated and numerous rate wars, destructive alike to the interests of the railroads and the shipping public, which have prevailed to an alarming extent throughout the west in recent years. These rate wars, he continues are in many, if not in most cases, devoid of palliation or excuse. They are inaugurated without reasonable cause and are vindictively prosecuted with utter disregard of their disastrous effects upon the business public.

EX-MAYOR AMES OF MINNEAPOLIS, ASSERTS IRELAND IS PRESENT BIDDEN AND NOT READY FOR HOME RULE.

STARVING AND PLENTY. Starving the Poor Children of the "Rice in Illinois."

Chicago, Sept. 28.—Mr. Henry D. Lloyd of this city, who has just returned from a visit to Spring Valley, Ill., where he distributed among the destitute miners medicines furnished by a charitable New York lady, writes a long letter to the Tribune in which he describes the wretched condition of the people there.

By other means of getting intelligent and unbiased information as to the exact state of things I visited the Catholic and the public school, in which together he describes the wretched condition of the people there.
