An Act to amend the Act for better securing the Independence of the Legislative Assembly of this Province.

THEREAS doubts have arisen as to the true intent and mean-Preamble. ing of the 11th Section of the Act passed in the seventh year of Her Majesty's Reign, and intituled, "An Act for better Act 7 Vic. " securing the independence of the Legislative Assembly of this cap. 65. 5 " Province," in reference to the issue of a new Writ of Election in cases where, after a General Election shall have been held in this Province, and before the meeting of Parliament, any Member who may have been elected at such General Election to serve in the Legislative Assembly of this Province, shall have accepted an 10 office of profit or emolument under the Crown, or otherwise vacated his seat as a Member of the said Legislative Assembly; And whereas it is desirable "to determine such doubts, and to make the practice of Parliament in this Province, with regard to the issuing of Writs to supply vacancies occurring in the Legis-15 lative Assembly by the acceptance of office or otherwise, conformable to the practice which obtains in England in similar cases; Be it therefore enacted, &c.,

And be it enacted, That it shall not be lawful for any Mem- No Memberto ber of the Legislative Assembly of this Province to have, take or receive any public monies. receive, either directly or indirectly, any salary, fees or emoluments of office of any description whatsoever, out of the public monies of this Province, during the time for which he may con-35 tinue a Member of the Provincial Parliament: Provided always,
