

## MOTHER EDDY LEFT RICH REAL ESTATE

### The Total Value Is Appraised at Almost Three Millions of Dollars.

Concord, N.H., March 11. A valuation of \$2,400,000 is placed on the estate in New Hampshire of the late Mrs. Mary Baker Eddy, founder of the Christian Science Church, by the appraisers, whose report was filed in the Merrimack County probate court today by General Henry M. Baker, executor of the estate. While the property left by Mrs. Eddy in Massachusetts has not been formally appraised, General Baker estimates it at about \$500,000. The total value of Mrs. Eddy's estate therefore is approximately \$2,900,000. This amount due the State of New Hampshire as a tax under the appraisal announced today is \$125,000. The payment of this tax will be deferred until disposal of pending litigation over Mrs. Eddy's will. General Baker announced today that, pursuant to Mrs. Eddy's real estate in this city, has been sold to Boston friends of Mrs. Eddy, who will purchase the property in a way that would have been pleasing to Mrs. Eddy.

## A NEW YORK STRIKE

All Drivers and Helpers of Adams Express Company Are Out.

New York, March 11. The strike of express company employees, which has been threatened for several days, past materialized today, with the failure of practically all the drivers and helpers in the empire of the Adams Express Company in the city to report for work. A considerable part of the company's office forces in the various depots was also affected. The movement of merchandise was checked, and a wagon leaving any of the company's stations.

The men are demanding reinstatement of various employees, who have been discharged or suspended, alleging discrimination against such men because of participation in the previous strike.

## AGES OF LIVING KINGS

The Duke of Saxe-Meiningen at 34 the Oldest Sovereign in Europe.

London, March 12. There are a great number of very old sovereigns among the rulers in Europe. The dozen is the Duke of Saxe-Meiningen, who completed his 64th year on Feb. 2. Next comes Kaiser Franz Joseph of Austria, King of Hungary, who was 80 on Aug. 18.

Then follow Prince Heinrich of Reuss, 71, who is 78, the Pope, Pius X., who completed his 75th year on June 2, the King of Romania, who is 71; Prince Johann of Liechtenstein, who is 70; the King of Montenegro, who is 69; the King of Denmark, who is 68; the King of Serbia, 66; the Sultan, 65; the King of Greece, 64; the Prince of Schaumburg-Lippe, 64; the King of Wurtemberg, and the King of Bavaria, who are 62; the Grand Duke of Mecklenburg-Strelitz, 62; and the Prince of Monaco, 61.

Among the reigning princes in middle age are the Grand Duke of Luxembourg, 58; Prince Guibaud of Schaumburg-Lippe, 58; the Grand Duke of Oldenburg, 57; the Duke of Anhalt, 54; the King of Sweden, 53; Kaiser Wilhelm, who was 52 on Feb. 2; the King of Bulgaria, 49; the Prince of Waldeck and Pyrmont, 46; the King of Greece, 45; and the King of Italy, 40.

The young monarchs are the Prince of Lippe, 29; the Duke of Saxe-Coburg, 28; the King of Norway, 25; the King of the Belgians, 25; the Grand Duke of Saxe-Weimar, 24; the Prince of Monaco, 23; the Queen of the Netherlands, 20; the Grand Duke of Mecklenburg-Schwerin, 18; the Duke of Saxe-Coburg-Gotha, 25; and the King of Spain, who is now the youngest reigning monarch, 34.

## TYPHOID DIMINISHING

## INDUSTRIAL UNREST BOTHERS AUSTRALIA

### Strikes Getting More Numerous Every Day—Labor Leaders Are Troubled.

Sydney, Australia, March 12. In common with the rest of the world, Australia is beset with industrial unrest. Strikes are growing more numerous every day, in spite of the fact that Australian administration is in the hands of Labor ministers elected to secure peace between capital and labor.

The disturbance affects all branches of trade, but several cases have occurred in the last few days that have hampered especially the big grain carrying vessels awaiting loading in the port. Whenever a strike occurs in any quarter, the disorganized workers promptly drop their work and wait till their leaders have interviewed the chief of their department. Meanwhile the whole machinery is thrown out of gear. If the chief of the department fails to agree with the complaints, there is a prolonged appeal to the courts, and the result is general chaos.

As labor leaders have been able to dictate the laws passed in recent sessions in Australia, it might be expected that strikes would be destroyed by the government. In practice, however, these laws are contradicted with impunity, and the authorities are reduced to the very undignified position of appealing to the strikers to maintain order.

Both in Adelaide and Sydney ministers have had to go in hand to hand with the strikers, the plea that the interests of the nation will be remembered hereafter. The cost of the strike is especially high in the case of the coal mines, and the authorities are reduced to the very undignified position of appealing to the strikers to maintain order.

## \$1.50 WILL SAVE ONE CHINESE LIFE

Rev. F. A. Steven Will Accept and Acknowledge Gifts to the Famine Fund.

The people of China are mostly living below the poverty line, and any failure of crops brings famine to the doors of the peasant farmers, who depend upon their own grain for food, and also upon the rest of the poorer population, to whom the advanced price of grain, brought from other provinces, means less food, or none.

The population directly affected by the present famine may be nearly three millions and perhaps nearly a million more may live to be lost before next May if nothing were done to help them.

The Chinese Government is doing what it can, and considerable sums of money and a shipment of ten thousand bags of flour have been sent by the Christian Herald, in co-operation with the National Red Cross Society of the United States. In the famine of three years ago simultaneously helped more than hundreds of thousands of lives.

At that time the China Inland Mission set on foot a number of its most experienced workers for this difficult task of famine relief, and is again doing so now.

## THE BOUNDARY WATERS

New Members of U. S. Commission Officially Announced.

Washington, March 12. Formal announcement was made here tonight of the appointment of Thomas H. Carter, of Montana, James A. Thompson, of Minnesota, and Chas. H. Street, of New Hampshire, as members of the Canadian waterways boundary commission. The commission will also organize and proceed to take up the problems presented in differences between Canada and the United States relative to the uses of the boundary waters.

One of the first questions to be given consideration will be in relation to the waters of Niagara River, particularly the use of the falls for power purposes. Another subject that will have early attention is that involved in the construction of power plants in the St. Lawrence, notably the Long Sault project, in which New York capitalists are interested.

The commission was created under the authority of a treaty negotiated with Great Britain. Each country will be represented by the representatives. The decision of the commission will be final, the United States and Canada having agreed in the treaty to accept as law any finding of the body created by the treaty. The work of the commission is regarded as of the highest importance. The use of the waters between the two countries has been the subject of many controversies for a long time. With commercial development on both sides of the line and the adoption by Canada of the great reclamation project looking to the irrigation of arid lands conditions developed that called for action.

## MANAGER TRAVERS TO REMAIN IN TORONTO

### Will Not Go to Kingston—Until Farmers' Bank Cases Are Ended.

Toronto, March 12.—Crown officials will shortly be up against a nice little dilemma in regard to W. R. Travers, former general manager of the Farmers' Bank. He's wanted here for the sessions this month and the sessions in May—can he be kept in the Toronto jail until that time?

Seymour Carley, the crown attorney, when asked today if Kingston Penitentiary had a chance of having Travers in on a boarder share, said:

"Travers will be here until after the Munro case is disposed of."

"But is he wanted as a witness in the other cases which come up in May?" suggested the interviewer.

"Well, we're not crossing any bridges before we come to them," Mr. Carley said. "When the time comes we'll deal with the matter—and the time hasn't come, thank goodness."

Inspector Duncan, when seen today, stated most emphatically that he would strenuously oppose any move to take Travers to Kingston before all the bank cases are disposed of.

"You want him kept here then?" was asked.

"Most decidedly," was the reply. "It is of the utmost importance to the police that he should be available. We are still digging into this bank case—the new charge against Dr. Nesbitt is an example to say nothing about the preparation of the cases to be tried in May."

"You think you can keep him then?" was asked.

"I won't go into that," said the inspector, "but I'll say this—he'll stay here if I can keep him here."

"What disposition will be made of Travers, pending the May sessions?" was the question asked Sheriff Mowat today.

"He's not my prisoner, except to keep him in jail," said Mr. Mowat. "Judge Winchester gave Inspector Duncan an order to bring him back from Kingston."

"Then, so far as you are concerned, Travers may remain here?"

"There's no use of my expressing an opinion," explained the sheriff. "If he goes back Inspector Duncan is to take him. I haven't the authority to take him."

Judge Winchester's order, granted Inspector Duncan on Feb. 18, provided for Travers to be brought back to the court and grand jury to testify in the case of the bank, etc., etc., meaning the Munro case. However, the same order provided for Travers' retention at the jail at the pleasure of the court.

Obviously, then, whether Travers goes or stays after the Munro case is disposed of depends upon the success or failure of the crown officers in securing a further order from the court having jurisdiction.

## CONNAUGHT'S AIDES REACH CAPITAL

Preparing for the Arrival of Royal Governor-General Next Fall.

Ottawa, March 11. Capt. T. Rivers, Bullock, M. V. O., Scots Guards, enroute to His Royal Highness, the Duke of Connaught, in Ottawa today for the purpose of making the preliminary arrangements for the coming of the Dominion's first royal governor-general, Lord Bute. Estournelles De Constant, member of the Hague peace tribunal, recipient of the Nobel peace prize, and former French minister at London, arrived today on the steamer La Provence, and, like his fellow apostle, Count Apponyi, a recent visitor, will lecture on international peace.

Baron de Constant said that the Hague conference was the most important event in the world since the war, and that it was the first time that the world had seen the result of a peace conference.

## PRINCIPAL SHAW DEAD

Prominent in Methodist Affairs of the Dominion for Many Years.

Montreal, March 11.—Rev. William Shaw, P. D., principal of the Wesleyan Theological College, and for many years chairman of the board of the Protestant School Commissioners, from which he retired a few weeks ago on account of ill-health, died at noon today. He was born in Kingston, Ont., on April 6, 1841. Studying first for the legal profession he abandoned that design and entered the ministry in 1864, and was ordained four years later. In 1894 he was called to succeed Principal Douglas in the Montreal institution.

## THE GLIDDEN TOUR

Will Be From Washington to Ottawa and Called "Reciprocity Run."

Washington, March 11.—The Glidden tour, the big annual event in the automobile world, this year will be known as the "Reciprocity Run," and will extend from Washington to Ottawa, starting June 1. The route will be through Baltimore, Wilmington, Philadelphia, Atlantic City, New York, New Haven, Providence, Boston, Burlington, and Montreal to Ottawa, arriving there not later than July 1. The distance is estimated at 1,085 miles. A pathfinder car will leave Washington May 1 to cover the route, for the purpose of mapping it, and gathering information of value to the tourists.

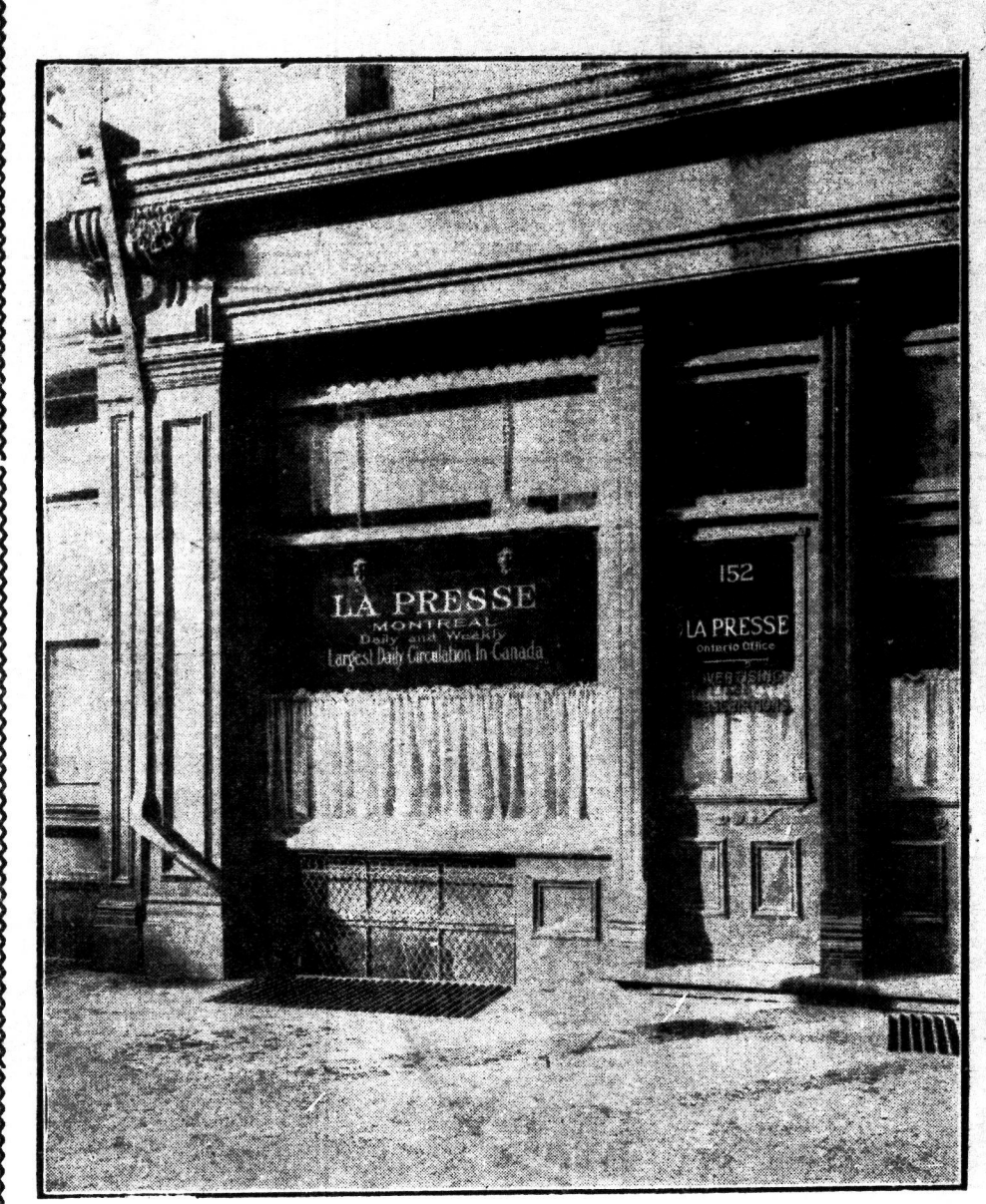
