LONDON ALIENIST FINDS DIBSDALE INSANE

Raney Quashes Case Against Labatt Brewing Co.

ASSAILS ACTION UNAUTHORIZED BY DEPARTMENT

Will Prohibit Interference With Legitimate Shipments to United States.

MAY SEEK LEGISLATION

Declares Complaint Against London Firm Was Made Without Authority.

Toronto, July 10.—Hon. W. E. Raney, attorney-general for the province of Ontario, moved today to halt all legal proceedings against the Labatt Brewing Company of London, charged with the transportation of beer through the city streets, contrary to the provisions of the Ontario Temperance Act.

In explaining his action, Mr. Raney stated: "I am stopping these proceedings at once. This case should never have been brought against the Labatt Company, and was without any sanction entirely, and without any authority whatever from this department. I am moving immediately to quash the trial."

Appropos of the same proceedings, the attorney-general announced officially that without delay, the provisions of the Ontario Temperance Act will be so amended that for the present, at least, there will be no interference with legitimate shipments from breweries and distilleries to the United States.

The ruling will be definitely worded, Mr. Raney explained, so that the authorities, until further legislation may be enacted, will not attempt to prevent shipments from Labatt's or similar places of manufacture to the United States by rail.

"On the other hand, we will positively allow no shipment by truck to Bridgeburg and other border points for location across the boundary lines," stated Mr. Raney, decisively.

"The breweries will, of course, be allowed to truck to the depots, naturally, and as I understand this was a legitimate shipment for the United States en route to the depot, I have ordered all proceedings stopped."

ENDS OWN LIFE TO AID FAMILY

Cape Girardeau, Mo., July 10.—"Greater love hath no man than this, that a man lay down his life for his friends."—St. John.

The above note was left by John E. Warner, 55 years old, who killed himself here so that his family might be saved from a life of poverty. Warner's business as a contractor recently failed. He carried \$27,000 insurance.

When he announced his intention of taking his own life to his wife and their four children, Mrs. Warner pleaded with him to try to "come back," but he drank poison before she could interfere.

WILL INCORPORATE TO CARRY OUT SEAWAY PLAN

Chicago, July 10.—The Great Lakes-St. Lawrence Auxiliary Association, formed to promote the St. Lawrence seaway to the Great Lakes, announced Saturday that incorporation papers had been forwarded to the secretary of state at Springfield. In addition to a board of directors, an Illinois state commission has been formed, and similar organizations are planned in lake region states, it was announced.

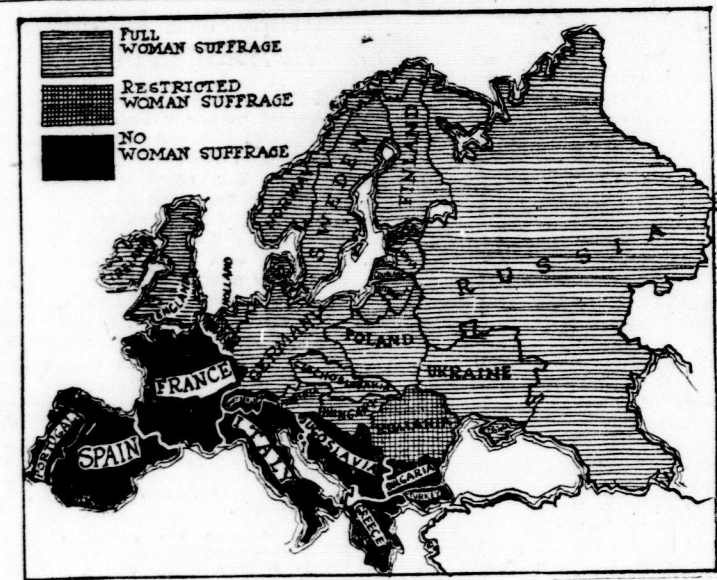
London, July 10.—In the House of Commons today, Premier Lloyd George announced that the Canadian cattle embargo debate would take place on July 24.

SUFFRAGE SPREADS IN EUROPE

Nations Give Women Equal Rights With Men.



SUFFRAGE MAP OF EUROPE.

PARIS, July 10.—The world war and the sweeping political changes in its wake have changed Europe from a continent where woman was denied the ballot to a predominantly woman-suffrage continent.

Throughout Northern Europe women enjoy equal rights with men. In the south they still lack voting power, but they're putting up a strong fight, backed in some cases by leading statesmen.

Here's how the fight stands today: FRANCE—Suffrage question up in parliament with Viviani, Briand and other statesmen favoring it.

GREAT BRITAIN—Equality of the sexes has been voted by the House of Commons. Two women members are now sitting—Lady Astor and Mrs. Margaret Wintringham. Suffrage is restricted to women of 30 or more.

SWEDEN—Women voted for the first time last fall. Five women elected deputies in the Riksdag.

NORWAY—Women obtained all citizenship rights and even obtained a seat in the cabinet in 1915.

DENMARK—Women are voters. Eleven in the Riksdag.

RUSSIA—Soviets declare women on an absolute equality with the men.

FINLAND—Women are voters. As far back as 1917 19 were elected to the national parliament.

ESTHONIA, LITHUANIA AND LETTONIA—Women have equal rights.

UKRAINE—Women have equal rights. Twelve are deputies in the national assembly.

GERMANY—After the revolution, women were given the vote and nearly 30 are in the Reichstag.

AUSTRIA—The republic gave electoral rights to women. They are eligible for the national assembly and municipal councils.

HUNGARY—Women have suffrage and have elected one deputy to parliament.

CZECHOSLOVAKIA—The Czech republic gave the women all the rights men enjoyed. Thirteen women deputies and three senators elected.

POLAND—Women have the vote and have chosen eight women deputies.

HOLLAND—Women have the vote. Two are members of parliament.

LUXEMBURG—Women have the vote and have chosen one woman as a member of the national assembly.

BELGIUM—Women are limited to eligibility and vote for burgomasters and other municipal jobs.

ROMANIA—The senate has accorded women suffrage in municipal affairs.

SWITZERLAND—Laws are largely decided by referendum and the men have not yet accorded full suffrage to women.

PORTUGAL—The senate voted a restricted degree of suffrage to the women, but the chamber of deputies refused to ratify this.

ITALY—The senate granted restricted suffrage in 1920, but the chamber adjourned without taking action.

Spain, Greece, Bulgaria and Yugoslavia have not accorded the women any rights in elections.

SMITH TO SIGN SALARY CHECKS FOR TEACHERS

Announcement Will Relieve Substitutes Peeved at Erroneous Report.

CHAIRMAN ACTS TODAY

Secretary Tanner's Office Clears Up All Doubts in Matter.

Although a report published in London Saturday declared that Chairman Edwin Smith of the board of education had refused to authorize payment of salaries to substitute teachers who took the place of regulars, while the latter were presiding over departmental examinations, recently, information given out at the office of the secretary of the board of education Monday indicated that Chairman Smith has signified his intention of signing the checks for these substitutes' salaries within a few hours' time.

The grounds quoted for Chairman Smith's refusal to sign these checks last week were that the regular teachers who took charge of the departmental examinations received extra pay for this duty, totalling \$9 per day, in addition to regular salaries for teaching. It was therefore felt that they could afford to pay for their substitutes themselves out of the double salary received.

In the meantime, those substitute teachers who read the report of Chairman Smith's action, were peeved at the possibility of "pay day" being postponed. Their discontent will be relieved, however, by the information given out at Secretary Tanner's office of the board of education that Chairman Smith will sign their checks Monday afternoon.

STAGE SET FOR ELLIOTT CHOICE

Announcement of New Crown Attorney Certain Before Week Is Out.

Revocation of Law Practice Order Removes Every Existing Barrier.

Toronto, July 10.—According to information received from an authoritative source at the Parliament Buildings Monday morning, the stage is set for the announcement this week that J. C. Elliott, ex-M. L. A. for West Middlesex, will be the new crown attorney for London and Middlesex County.

Revocation of the order that the new crown attorney must relinquish his private law practice has removed every barrier to the appointment of Mr. Elliott, as published exclusively in The London Advertiser Saturday.

While Attorney-General Raney declines to discuss the appointment, reliable information states that confirmation will be forthcoming in a few days. It is stated here that the reason the order compelling crown attorneys of Ontario to relinquish private practices was revoked, is that the system has not worked out satisfactorily at Hamilton, where the system was tried out as an experiment.

In Toronto, the system proved its merits, but the situation in the Queen City is regarded as more adapted to the order than either Hamilton or London.

Agitation throughout various centers of the province has been in favor of the order, but it is stated that the attorney-general's department was convinced that poor results would ensue in London if the order was enforced.

Much as the authorities would like to carry the experiment further in London, the possibility of losing Mr. Elliott as a crown official has loomed up too great to allow this preference to interfere with his appointment as Middlesex crown attorney.

DEFENSE PLEA MAY REST ON 1918 ACCIDENT

Youthful Slayer Admitted to Victoria Hospital With Concussion of Brain.

NEVER FULLY RECOVERED

Mental Condition Would Explain Attitude Since Sweetheart's Death.

Insanity will, in all likelihood, be the defence presented on behalf of Gordon Dibsdales when he is tried at the fall assizes at the courthouse as the slayer of his 15-year-old sweetheart, Christina Near, a month ago.

Dibsdales is insane, one of the foremost alienists in London decided when he examined the prisoner recently.

Despite denials by jail officials, the examination took place, and the alienist had every opportunity to test the sanity of the young prisoner while he was confined in his cell at the county jail.

How long Dibsdales has been mentally unfit is another question. However, he is insane at the present moment, of this the alienist is certain.

And so his attitude since his arrest and his omnipresent regret that the shotgun was not saved off, so that he could have shot William Near, brother of his victim, and himself, before the authorities intervened, are explained.

In Hospital in 1918.

Four years ago Dibsdales was taken to Victoria Hospital suffering from concussion of the brain. He was admitted to the hospital on Aug. 18, 1918, and discharged Sept. 6, the same year.

Authorities believe that he never fully recovered from the concussion. It is thought that waking hard thirteen rights out of every fourteen, and his love affair and the little difficulties left him mentally unbalanced.
