MINING LAWS OF ONTARIO.

ANY person may explore Crown Lands for minerals.

Mining lands may be taken up as surveyed locations or staked claims.

Locations range from 40 to 320 acres.

Claims range from 10 to 20 acres on vein or lode.

Locations may be acquired in fee or under leasehold.

Price of locations north of French River \$2,50 to \$3,50 per acre, and south of it \$2 to \$2,50 according to distance from railway.

Rent of locations but way for the \$2 to \$2.50 according to \$3.50 according

from railway.

Rent of locations first year 60c, to \$1 per acre, and subsequent years 15c, to 25c, per acre.

Rent of claims, \$1 per acre each year.

Claims must be worked continuously.

Royally on ores specified in the Act, 2 to 3 per cent, of value at pit's mouth less cost of labor and explosives.

Royally not charged until seven years from date of patent or lease, nor as provided in s. 4 (3) of the Mines'

Act, 1952) until fifteen years in the case of an original discovery of one or mineral.

Original discovery of one or mineral on chim estilled.

Original discoverer of ore or mineral on claim entitled to stake out a second claim. Crown Lands sold under provisions of mining laws in force prior to 4th May, 1891, 1892, may be had on applications of the Nines Act, 1892, may be had on applications.
