that hon. members may be in a position to give us the benefit of their advice as to what, in their opinion, would be the best course to take. I shall have much pleasure in bringing down the papers at the very earliest possible moment.

Motion agreed to.

GENERAL INSPECTION ACT.

Mr. LEIGHTON G. McCARTHY (North Simcoe) moved for leave to introduce Bill (No. 48) to amend the General Inspection Act.

Some hon. MEMBERS. Explain.

Mr. McCARTHY. Last session I had the honour of introducing a similar Bill to this, and I explained it pretty fully at that time. It being late in the session, I explained that I would not press it to a finality that session, but that hon. members would have an opportunity of circulating it through their ridings and ascertaining whether public opinion was in favour of it. Since that time I have heard no complaints against the Bill. The explanation I gave last session is in Hansard. The Bill is for the purpose of obtaining a uniform inspection of hides, skins and leather in the cities mentioned in the Bill, to which only it is intended to apply. By that means the hides, it is expected, will be taken more carefully off the animals, and will thereby be increased in value.

Motion agreed to, and Bill read the first time.

IMMORAL ENTERTAINMENTS.

The MINISTER OF JUSTICE (Hon. Charles Fitzpatrick) moved third reading of Bill (No. 12) to amend the Criminal Code, 1892.

Mr. J. E. E. LEONARD (Laval). (Translation.) Mr. Speaker, before this Bill is read a third time, I wish to move :

That, the said Bill be not now read a third time but that it be re-committed to a Committee of the Whole with instructions to make the following amendments thereto :--

1. That the words 'or immoral' be added to the words 'or obscene amusements' in the fifth line of the first paragraph of Section 179a, as well as to the words 'obscene amusements' in the fourth line of the second paragraph;

2. That the following paragraph be added :--

⁶5. Will be considered immoral, for the purposes of the present Act, all representations, plays or scenes, and all theatricals that may ridicule the marriage tie or laws or the misfortune of a deceived spouse, or that may present in a favourable light concubinage, adultery, adulterous love, or the life of the debauchee, or of the girl of public character, who is kept up, or that may
