The fourth will be restricted. We will take a look at the other three. If this situation is going to cause disturbance to my hon. colleague's constituents, we will try our very best to keep it to an absolute minimum.

Mr. John Lundrigan (Gander-Twillingate): A supplementary question, Mr. Speaker. Would the minister divert a little of that noise and jet activity to the international airport at Gander?

Mr. Jamieson: Mr. Speaker, as long as the hon. member represents that constituency I do not think they will need to worry about noise.

Some hon. Members: Hear, hear!

Mr. Lundrigan: A further supplementary question, Mr. Speaker. Is the minister not aware that the residents of Gander-Twillingate, after 21 years, would welcome that kind of noise in Newfoundland?

VANCOUVER-RENTAL CAR SERVICE STRIKE

Mr. Barry Mather (Surrey): Mr. Speaker, my question is for the Minister of Transport. Bearing in mind the long strike of Rent-a-Car employees at Vancouver International Airport, can the minister indicate what contact he has with this dispute which affects the international airport and tell us what is being done to get those involved in the dispute back to the bargaining table?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, I am sure the hon. member appreciates that this strike is strictly and exclusively under provincial control. The party being struck against happens to be a U-Drive company which is a lessee of ours at Vancouver International Airport. In so far as the strike itself is concerned, we have no jurisdiction whatever. I did authorize limited picketing in the neighbourhood of the accommodation that is leased at the airport. That is the only involvement we have had. I can say that I am advised informally that one of the major U-Drive companies has now agreed to settle with its employees. Hopefully, this will
