STATUS OF WOMEN

SUPREME COURT RULING ON NON-FAMILY ASSETS

Hon. Flora MacDonald (Kingston and the Islands): Madam Speaker, I rise under Standing Order 43 to move the following motion. On December 6, 1982, the Supreme Court of Canada ruled that, in the event of marriage breakdown, a woman who has worked outside the home during some, or all of the period of the marriage, is entitled to a share of non-family assets, but that a woman whose work has been solely in the home can receive no such benefits. Therefore I move, seconded by the Hon. Member for Parry Sound-Muskoka (Mr. Darling):

That this House urge that all legislatures and courts develop, administer or interpret family law in such a way that the woman who works in the home is not discriminated against, as she is in this most recent ruling of the Supreme Court of Canada with regard to non-family assets.

DEMAND FOR INTRODUCTION OF GOVERNMENT POLICY

That the Government be directed to bring in its shipbuilding policy now, and that such policy contain tax incentives for building, buying and leasing Canadian built and registered ships to enable Canadian shipyards and ship operators to compete in world markets, and further be directed to bring in a policy that requires that vessels for resource exploration and transportation in the Canadian Arctic be built in Canada.
