For her to put those kinds of details forward and try and wrap them around in some kind of semblance of truth has gone too far.

ONTARIO BAN-MINISTER'S POSITION

Ms. Sheila Copps (Hamilton East): Mr. Speaker, I suggest that when two people have died it is not the arena for applause.

I would like to ask the Minister to give us a very specific answer to a very specific question. Last Friday morning in the House he stated that within three minutes he had issued an allout alert on all shellfish in Atlantic Canada. Subsequent to that, his own officials in his own Department were in touch with officials from the Ministry of Health in Ontario trying to tell them it was okay to lift a wider ban on mussels outside of the mussels in P.E.I. and the Magdalen Islands.

I would like to ask the Minister how he can claim in the House today that he had a very clear plan of action last Friday, when on the one hand he was issuing an all-out ban on all shellfish, and on the other hand his own officials were trying to tell Ontario to lift their ban?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, the Hon. Member has again stated the allegations as if they were fact.

Ms. Copps: They are fact.

Mr. Epp (Provencher): They are not fact.

Ms. Copps: They are absolute fact.

Mr. Epp (Provencher): They are not fact. What I said on the Friday was the ban. I did not say that there was a clear plan in place on Friday. For the Member to persist on that time after time is simply false, it's wrong, and it shouldn't be done in this House.
