

BOND TAKES LAW IN HIS OWN HANDS ORDERS ARREST OF YANKEE FISHERMEN

Newfoundland Government Moves to Punish Violations of the Bait Act Without Considering Modus Vivendi and Serious Situation May Arise.

New York, Nov. 12.—A dispatch to the Times from St. Johns, Nfld., says that Sir Robert Bond, premier of the colony, has taken the law into his own hands, and despite the modus vivendi arranged some time ago between England and the United States, has ordered the arrest of American fishermen violating the bait act, an ordinance of the Newfoundland Government. Solicitor Edinborough, acting for the Government, has gone to the Bay of Islands to cause proceedings to be taken.

While there is general sympathy throughout the colony, with the stand of the premier regarding the modus vivendi, his action in the present instance is blamed as precipitate. While, however, there is no feeling in Newfoundland adverse to the United States, there is a strong sentiment against sacrificing any of the interests of the people of the colony to acquire the good will of any nation.

Sir Robert Bond contends that any rights granted to American fishermen are subordinate to the laws governing the people of Newfoundland; and that the fishermen are bound to observe statute known as the bait act, and that his action is merely one to enforce that law. While this is the official stand of the Government there is a feeling throughout the country that the action is really intended to test the extent of the modus vivendi, and to try to overcome the provisions which grant special rights to American fishermen. These rights are at present not enjoyed by the colony's own fishermen, and were but recently, after years of negotiation, cut off from the French fishermen of St. Pierre and Miquelon.

Sir Robert Bond's action, therefore, assumes international importance and may call for delicate diplomatic negotiations, but the Premier is determined to test the law at once.

ELIOT APPROVES

The President of Harvard Likes the Reformed Football Game.

Boston, Nov. 12.—Football, under the new rules, as demonstrated in the Harvard-Carlisle game at Cambridge, Saturday, meets with favorable comment from President Eliot, of Harvard University, in an interview made public today. President Eliot, whose attitude towards sport last year made it seem probable that football would soon be dropped from Harvard's athletic schedule, attended Saturday's contest and expressed his enjoyment of the game, which, he said, appeared to him, "free from unnecessary roughness." Football is considered as under probation at Harvard this year. A committee appointed several months ago is still discussing the subject of athletic sports, with special reference to football, but has not yet submitted its report. President Eliot's views as expressed today, it is expected, will have some weight with the committee in recommending that football be retained on the crimson's athletic calendar.

HUNTERS RETURN

Bring Back Twelve Fine Deer From North Hastings Woods.

Messrs. Ed Nelles, E. J. MacRobert, Wm. Murray, Thomas Knott, Walter Langridge, Wm. Yeates (Hamilton), Dr. H. A. Stevenson and Dr. J. B. Campbell returned on Saturday from a hunting trip to North Hastings. Though the party was very poor for game, the party brought back twelve deer, all beauties.

The weather was ideal for camping, but it was too warm for game, and the lack of snow on the ground rendered it difficult to track the quarry.

While the party was in Hastings a member of another party was shot by a comrade in mistake for a deer. Otherwise the trip was without incident.

GREAT FIRE AT CHICAGO

Lehigh Coal Company's Docks Destroyed at a Loss of \$757,000.

Chicago, Nov. 11.—The docks of the Lehigh Valley Coal Company, situated at One Hundredth street and Commercial avenue, were destroyed by fire yesterday, causing a damage estimated by the officers of the company at \$757,000.

The fire originated from some unknown cause in the engine room in the basement of a coal house, in which 50,000 tons of hard coal were destroyed, and spread so rapidly that the employees were forced to run for their lives.

The coal is still burning, and it is expected that it will be several days before the fire is entirely extinguished. The company's loss in hoisting machinery alone is estimated at about \$250,000.

A Non-Political Council the Object of This Move

Prominent Citizens Discuss Naming of a Slate to Represent All Interests.

At a semi-secret meeting of a number of prominent citizens on Saturday night, the first move was made toward the bringing out of a strictly non-political slate for the city council of 1907.

The scheme is to have a slate to represent the manufacturing interests, the mercantile interests, the professional men and the workmen. Politics are to be cut out of the slate, other than that an endeavor will be made to get an even number of both Liberals and Conservatives, if possible. If not, good men are to be nominated, no matter what their politics may be.

Ex-Mayor Fred Rumball was named a delegate from the meeting to wait on the Liberal executive and secure the consent of that body to the running of a non-partisan slate, and ex-Mayor John D. Wilson was named to wait on the Conservative executive for the same purpose.

Amongst those present at the meeting were Ald. Forristal, President A. W. White, of the board of trade; Col. Gartshore, ex-Mayors Rumball and Wilson, Mayor Judd and others to the number of ten.

Discussed Present Board.

It is said that the present council was discussed at length, and that in an impartial manner, the faults of several of the city fathers were dealt with.

In fact, it is alleged, that after going over the list it was the opinion of the meeting that the names of only two or three should be submitted to the people on the new slate.

The matter of a majority candidate was, it is understood, left out for the present.

It is said that the payment of the street watering contractors for the month of October, in the face of the fact that they did no work for the city during the month, has turned many of the big businessmen against this year's council, mayor and all, while the people who were taxed three cents a foot for the bonus for the contractors are also angry at the council's actions.

WAS LOADED DOWN WITH VALUABLES

James Fox, Charged With Shop Breaking, Had Eleven Watches When Arrested.

At an early hour last evening the pawnshop of Thomas Fox, on Clarence street, was entered, and a quantity of jewelry and firearms were stolen.

At first the robbery was surrounded by deepest mystery, but after the matter was reported to the local police department, it did not take Detective Egleton long to get a clue. Before the night was far spent, James Fox, a son of the shopkeeper, was safely landed in the police station, charged with the theft.

When arrested Fox was at the G. T. R. crossing at Wellington street. He had eleven watches, six large revolvers, a pair of field glasses, and a pair of opera-glasses on him. All of the articles are supposed to have been taken from the pawnshop.

One of the rear doors of the shop showed that entrance had been gained by cutting out one of the panels with a saw.

Fox was arraigned at the police court this morning, charged with shopbreaking and theft, and was remanded until Friday, his father requesting the magistrate to give the accused at least three days in jail before asking him to plead.

HAAGON IN ENGLAND

Norwegian King and Family Pay State Visit to Edward.

London, Nov. 12.—King Haakon, Queen Maude and Crown Prince Olaf of Norway, who arrived off Spithead late last night on board the British royal yacht Victoria and Albert, landed at Portsmouth this afternoon, on a state visit to King Edward and Queen Alexandra, with whom they will spend a week at Windsor Castle. A series of fetes have been arranged for their entertainment. The Prince of Wales welcomed them in behalf of King Edward, after which the royal party landed, and took a train for Windsor. On arriving the visitors were met by King Edward, Queen Alexandra, and most of the royal family. The route from the depot to the castle was lined by troops, and the royal travelers received a splendid welcome from the inhabitants of the borough, the baby crown prince coming in for a full share of the plaudits.

SUSPECT FOUND DEAD.

Owosso, Mich., Nov. 12.—Bert Zeely, who was under suspicion in connection with the murder of Edwin Edgar in West Haven Township last Wednesday, was found dead in bed today, and lying beside him was his young wife, also dead. They were found by Zeely's brother.

RUNAWAY LOCOMOTIVE CHARGES INTO DEPOT

One Man Killed and a Number Injured By Odd Accident at Detroit.

Detroit, Mich., Nov. 12.—One man was killed and several injured, three of them badly, today, when a Michigan Central Railroad freight engine ran away and crashed into the Third street depot, tearing down a large section of the structure. The dead man is George R. Booth, parcels agent.

Donald Thomson, assistant district superintendent of the Pullman Company; Earl S. McEuen, cashier of the Pullman office, and Bert Haner, Detroit, a Michigan Central conductor, were all severely injured. The engine was switching in the yards a mile from the station about 7 o'clock, when it was started by a passenger train approaching behind them, thought a collision was about to occur, and jumped from the engine. It was running at good speed, and unchecked, dashed into the station and hit the west wall, tearing out a section 25 feet wide. The second floor over this section also collapsed. Booth was killed in his parcel room, near which the engine struck. Haner was on the third floor and fell with the wreckage from there.

MANY LIVES LOST IN B. & O. WRECK

A Fatal Head-On Collision Reported Near Valparaiso, Indiana.

Indianapolis, Nov. 12.—A special to the News from Valparaiso, Ind., says:

"A head-on collision between two passenger trains on the Baltimore and Ohio road was reported early today at Woodville, ten miles north of here. Reports have 5 known dead, 25 injured, and 20 to 30 burned up in one train which was destroyed. All the doctors in this city have gone to the scene of the wreck."

Valparaiso, Ind., Nov. 12.—Fifty of one hundred and sixty-seven who were on a Baltimore and Ohio train which collided head-on with a freight train at Woodville, ten miles north of here, this morning, are missing, and it is believed their bodies were consumed by the fire, which destroyed six coaches of the immigrant train.

The accident was caused by the freight car failing to observe signals on the first section of the immigrant train that another section was following. The immigrant train caught fire and was entirely consumed. Of the 167 passengers on board the train, 117 have been accounted for. All the injured were taken to Mercy Hospital, at Chicago on a special train, after their injuries had been attended to by a corps of physicians from this city. All of the train crew on both trains escaped, but the fireman on the immigrant train, who was killed. The immigrants consisted of Russian Jews, Serbians and Poles, and were en route via Chicago to the Northwest.

NO SWITCHMEN'S STRIKE

20,000 Men Agree to an Increase of Four Cents an Hour.

Chicago, Nov. 11.—The trouble between the union switchmen and 23 railroads entering Chicago was finally adjusted last night and danger of a strike of the 20,000 men has been averted.

The switchmen belonging to the Brotherhood of Railway Trainmen, who refused the advance of 3 cents an hour, accepted the offer of 4 cents per hour last night.

MURDER EPIDEMIC AT PITTSBURG

Slaying and Robbing Puts City in a Panic.

ATTEMPTS TO CRUCIFY A WOMAN

Found With Hands Nailed to a Board—Husband is Suspected of Brutal Crime.

Pittsburg, Pa., Nov. 12.—Pittsburg terrorized and likened to a mining camp or frontier town, is the tone of all this morning's papers. With three murders, a number of robberies on the highway, accompanied by violence, and an attempt at crucifixion in 24 hours, added to the large number that have occurred during the past two weeks, there has been such a public demand for extra police that Mayor Guthrie and Director of Public Safety Ridge-way last night put on a number of extra police, without legal provision for their compensation, trusting to the effect of public clamor on the select and common councils for favorable action upon this move.

The record for 24 hours, besides the murder of Henry F. Smith, a young business man of the fashionable east end, who was shot by burglars, who entered the Smith home, is extended by the robbery of Charles W. Lawrence, who was knocked unconscious with a slugshot, and robbed of all his money while going home from the Hotel Schenley, where he is employed as a waiter. He will be confined to his bed for a week with his injuries.

Nicholas Lewis, Sharpshooter, a few miles from this city, was also beaten and robbed and did not recover consciousness for several hours.

Raymond White, of Duquesne, was also found early yesterday morning, with several ribs broken. He, too, had been robbed and could give no description of his assailants.

The crucifixion case was brought to light by the screams of a woman on Forbes street. Neighbors rushed in, and found Mrs. Jean Mitchell, 19 years old, in a kitchen, huddled in a kneeling position on the floor, with both hands nailed to the draining board of the sink, with the blood running down her arms.

The woman was unconscious when released, and she was taken to a hospital. On recovering, she said that when she entered her flat early in the morning, something struck her on the back of the head, and she felt herself drawn towards the sink, her hands pressed against the board, and two nails driven in.

The police are looking for William Neeley, known as William Mitchell, and the husband of the woman. The day's series of violent deaths was further augmented by the death of Schiappa Randi, an Italian, who was stabbed in a fight among railroad laborers in a boarding house. Three others were badly cut up by styliettes and razors. Peter Nazidenci, an Italian, died in the Allegheny Hospital, from a bullet which was fired by Peter Fodora. Nazidenci was playing a mandolin, to which Fodora objected, and threatened to shoot off Nazidenci's thumb. The threat was carried out, and in addition to carrying away the thumb the bullet penetrated Nazidenci's body. Fodora is under arrest.

ASHORE OFF MATANE

Liner Kensington Enroute From Liverpool to Montreal in Trouble.

Quebec, Nov. 11.—The steamer Kensington, which sailed from Liverpool on Nov. 1, for Quebec and Montreal, went ashore during a snowstorm at 5 o'clock this morning inside the buoy off Matane, 200 miles down the river. The steamer Gaspeian, on her way to port, went alongside to give assistance and remained there. When the news reached the Quebec agent, the steamer Lord Strathcona was instructed to leave for the scene, and left this afternoon with lighters. Instructions were also sent to the Government tugboat, Bonville, stationed at Father Point, to proceed to the wreck, and the Government steamer Druid leaves for Matane this evening. In the meantime the Quebec agent wired the Gaspeian to take off the passengers from the Kensington and bring them to Rimouski, where a special train will be in waiting to bring them to this city. A message was received this afternoon, that the Gaspeian had taken off the passengers and had left for Rimouski.

U. S. TROOPS DISARMED

Three Battalions of Negro Soldiers Discharged From the Army.

El Reno, Okla., Nov. 12.—Members of Companies B, C and D, of the Twenty-fifth Infantry, recently dismissed by President Roosevelt, were formally disarmed yesterday. Many of the men, some of whom had been in the service for more than 20 years, shed tears when they gave in their guns. Today the disarmed troops will have battalion drill without arms, and they will be discharged immediately on receipt of the official order from Washington, probably today or Tuesday.

The second battalion of the Twenty-sixth Infantry, under command of Major Clarke, from San Antonio, is in camp just outside the garrison limits of Fort Reno. The negro troops have shown no disposition to be ugly.

BOY FATALLY SHOT BY CHUM WHILE SHOOTING IN THE WOODS

Charlie Hodgins the Victim—Struck by Bullet From Rifle Carried by Alfred Baxter.

On Saturday afternoon, about 2:30 o'clock, a fatal shooting accident occurred northwest of the city, in London Township, Charlie Hodgins, the 16-year-old son of Mr. Thomas Hodgins, of 811 Maitland street, being the victim. Hodgins was struck by a bullet from a rifle in the hands of Alfred Baxter, his constant companion.

Baxter lives with an aunt, Mrs. Mary Thompson, on Oxford street, near Maitland, and after dinner on Saturday he started out with Hodgins for an afternoon's shooting. They carried a small 22-caliber rifle. On a farm of Mr. Trot, just beyond the limits of West London, they chased a squirrel into a brush-heap, and they were waiting for the little animal to make his appearance, when the rifle, which Baxter was carrying, was accidentally discharged. The bullet lodged in the back of Hodgins' head, causing his death in a short time.

Baxter's Account of Tragedy.

Baxter feels his position very keenly. To The Advertiser he said that on Wednesday last he arranged to go shooting with Hodgins on the first Saturday afternoon when they did not have to work. Baxter took a small rifle which he owned to a gunsmith to have some repairs made to it, so that it would be ready for the occasion. On Friday they went to the gunsmith's store to see if the rifle was ready, and also to price some of the small rifles, Hodgins having decided that he would purchase one if he could do so at a suitable price. After looking over a few of the rifles, Hodgins came across one to which he took a great fancy, and the price being suitable, he told the storekeeper to set it aside, and he would buy it when he could get the money.

Both boys worked until noon on Saturday. Hodgins, who worked at Per-rin's, went home for his dinner, but did not tell his relatives that he purposed going shooting. Baxter works at Tuckett's cigar factory, and after 1 o'clock the two boys met at an appointed place down town and went to the gun store, where they found that

Baxter's rifle had not been finished. They decided to rent the weapon to which Hodgins had taken such a fancy, and give it a practical test.

Gun Accidentally Discharged

The boys did not start to shoot until they reached the C. P. R. gravel pit. There they came across a bird, at which they both fired several shots, but failed to kill. As they were about to leave the pit, Hodgins was carrying the rifle with the muzzle pointed toward the ground, when it accidentally discharged, and the bullet grazed the side of one of his shoes, leaving a mark. From the pit they continued farther out into the country, until they came across a squirrel in a tree. Hodgins, who was still carrying the gun, fired two shots at it, but, being unable to hit it, he gave the rifle to Baxter, who also fired several shots with no better results. They went nearer to the tree and as they did so the squirrel took refuge in a brush heap near by. The boys followed and were peering into the pile, when the rifle discharged, the bullet striking Hodgins in the back of the head. The unfortunate boy fell to the ground.

Medical Aid Too Late

Baxter realized what had happened, and after carrying his injured companion from the wet, marshy ground to a higher spot, he hurried to a nearby house to get help. Two men responded to the call, and carried the boy to the house, where he died before medical aid could arrive. In the meantime Baxter had gone to the nearest telephone station to summon a doctor. Dr. Weekes was the first to arrive on the scene, but he found that life was extinct.

Coroner Dr. Ferguson was summoned, and after inquiring into the circumstances and hearing Baxter's statement of the accident, he decided that an inquest would not be necessary.

Baxter, who is 17 years old, says he cannot explain how the rifle came to be discharged. Hodgins was just ahead of him and stopping over. Baxter had the rifle across his knee, holding it in one hand. The fact that the rifle had discharged unexpectedly when the boys were leaving the gravel pit, makes it appear that it was a second-hand one, and was worn until the trigger worked so easily that the slightest jar was sufficient to cause its discharge.

To Stretch Boundaries North to Ft. Churchill

Ontario Places Its Claims Before the Federal Ministry.

Ottawa, Ont., Nov. 12.—The representatives of Ontario, Manitoba and Saskatchewan in conference as to the provincial boundaries were received today by Sir Wilfrid Laurier, Hon. A. B. Aylesworth and Hon. Frank Oliver in the Premier's office. The Province of Ontario was represented by Premier Whitney and Messrs. Foy and Mathe-

son; the Province of Manitoba by Premier Roblin and Messrs. Rogers and Campbell, while Saskatchewan was represented by Premier Scott and Attorney-General Laframboise.

The Province of Ontario in its memorandum says that it is only fair and reasonable that Manitoba should have its boundaries extended northward to Hudson Bay. Ontario does not want to offer any observations as to the extension of the boundaries of Saskatchewan. On behalf of Ontario its representatives therefore asked that the boundaries of Manitoba should be extended northward to Fort Churchill.

15 PERSONS SLAIN; 21 ARE WOUNDED

Hunting Season in Michigan and Wisconsin Begins "Auspiciously."

Milwaukee, Nov. 11.—The list of killed and wounded for the present hunting season bids fair to beat all records. Though the deer season opened Saturday, it begins with 15 deaths and 21 wounded from firearms this fall. With thousands of hunters in the woods of Northern Wisconsin and Michigan, where the deer are said to be plentiful, it is believed that the dead and wounded at the close of the season will look like the result of a battle.

REPRESSIVE MEASURES

Russian Masses Barred From Taking Part in Election Campaign.

Odessa, Nov. 11.—At the electoral committees in this city and in the provinces have been suppressed and their functions have been transferred to the town councils. The arrangements made by these committees have been canceled and their official posts have been removed from the walls of Odessa by the police.

These measures, which are intended to prevent the mass of the people from taking part in the campaign for the election of members to the Lower House of Parliament, have produced a painful impression here. The students electoral committee with the following poll: Social Revolutionist candidates, 712; Social Democrats, 777; Laborites, 185; constitutional Democrats, 167; Government supporters, 317; Zionists, 105.

According to advices received here from Yekaterinobsk and Kishinev, 104 men were today sent into exile for minor political offenses.

Local governors are dismissing officials for refusing to leave the ranks of the Constitutional Democratic party and are promising promotion to the alternative of banishment—if the officials will attach themselves to parties friendly to the Government.

Widow Announces \$80,000,000 Will Go To Aid Struggling Institutions and Men.

New York, Nov. 12.—Mrs. Russell Sage will give away the bulk of the fortune of about \$80,000,000 bequeathed to her by her husband, the financier, to individuals whom she considers worthy. It will not be given to endow churches nor to those who write begging letters.

"I shall keep only sufficient of the fortune left to me by my husband to live quietly and comfortably," Mrs. Sage said today. The fact that churches are endowed today, that beyond the necessity of work, thus making them indifferent, and negligent along the lines where Christian institutions should do the most good. I mean to give to those individuals whom I think worthy. When I have left only enough to live comfortably, perhaps I may not be annoyed by persons indicating enough to beg for help, as I am now.

"I wish to help men and women of the higher or lower walks of life, who, through no fault of their own, are so unfortunate as to need assistance, and too proud to ask. Such persons I deem it a pleasure, a privilege and duty to aid. Persons who were faithful and kind to Mr. Sage will be remembered, as I know he wished me to do so. In all my plans I am carrying out his desires, I am certain."

Mrs. Sage said she would do all she could, however, for struggling churches and institutions devoted to the care of the needy and sick. She declared that she intended to buy a home for a clerk in a railroad office who was kind to Mr. Sage. The bodies of her paternal grandparents, now buried on a farm near Troy, will be removed to a cemetery in that city, and the burial place of her maternal grandparents in Sag Harbor, L. I., will be cared for.
