THE BEAVER IS GONE.

Her Historic Remains Fall to Pieces and Sink in the Pacific Waters.

Project to Exhibit the Wreck at the World's Fair also Falls Through.

The old steamer Beaver is no more. The bulk, which for some years has disfigured the entrance to Vancouver harbor, has fallen to pieces and sunk in the waters of the Narrows, and the scheme to exhibit at the World's Fair at Chicago the wreck of the first steamer that plowed the "placid waters of the Pacific" has likewise fallen through.

The story of the unexpected disaster is briefly told in the following special to the COLONIST from its Vancouver correspondent. The despatch says: "As the Yosemite was coming through the Narrows yesterday, at noon, the wash of the paddles struck the stranded Beaver on the port side. The venerable bulk trembled from stern to stem at the blow and literally tumbled to pieces. The boilers went first, then the heavy metal carried the starboard side of the wreck into deep water, leaving only a portion of her port side visible. At the time of the disaster, Harvey, who was posted at the point to prevent vandalism of the Beaver's precious remains, was on the watch, and he saw the natives on this coast, who will hear with regret the news of the mishap. Those, too, who have recently put their money into the World's Fair will likewise be sorry, for the financial loss will be considerable. However, the best must be made of the accident, and active steps will be taken to preserve what little remains of the old craft.
