



(a) Apparently a favorite move with the player of White. The German Handbuch gives but ene variation: 4 B to Q5, 4 KKt to K2, 5 Kt takes P, 5 B takes P+; 6 K takes B, 6 Kt takes Kt, with the

(b) We would much prefer 5 P to Q3; if then 6 Kt to Kt5, Kt takes B; P takes Kt, Kt to K2, etc.

(c) Why not B to Kt3 instead of this cramping move.

(e) The manner in which Black gets quietly but surely out of his constrained and dangerous position is highly commendable.



SEALED TENDERS addressed to the undersigned, and endorsed "Tenders for the Sault Ste.
