8. Are any memoranda or other documents which may have been prepared by members of the commission who were present at any such meetings to inform their absent colleagues now available to be laid on the table of the House of Commons so that members of this House may know whether the commission actually gave any attention to representations made to it?

Hon. Judy V. LaMarsh (Secretary of State): The commissions set up under the Electoral Boundaries Readjustment Act do not report to the government so that the government does not have records giving the information sought in this question. Under section 10 of the act the commissions are not agencies of Her Majesty. Reports of the commissions are made directly to the House of Commons.
