Did he request the nickel companies to defer any increase in the prices of their product to Canadian customers, a request that would appear to be particularly reasonable in view of the fact that only 4 per cent of the output of these producers is marketed in Canada?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): No, Mr. Speaker. This is a question which I think should be more properly directed to the Minister of Industry, Trade and Commerce, but such a request would result in a somewhat complicated twoprice system which I think would have disadvantages.

Mr. Stanfield: I have a supplementary question, Mr. Speaker. Why does the minister feel it is appropriate for him to ask the oil companies not to increase their prices and at the same time feel he has no right to make a similar request in the case of the 25 per cent increase in the cost of a product to Canadian customers, a request that would appear to be relatively easy to meet, particularly in view of the fact that a 25 per cent increase in the price of this product would seem to finish off any effort to establish a program of restraint?

ACQUISITION OF AIR CANADA FACILITIES BY CAE INDUSTRIES AND NORTHWEST INDUSTRIES
