Mr. Davis: The reports I have received from the area indicate that the sulphuric acid is being contained and neutralized. There is no evidence of fish kill. However a diversion of water from the French River is also being arranged to dilute the acid if further escapements should occur.

GRAIN

WHEAT—PAYMENTS UNDER ACREAGE REDUCTION PROGRAM

Mr. A. C. Cadieu (Meadow Lake): Mr. Speaker, my question is directed to the minister in charge of the Wheat Board. Will he assure the House today that the cheques for the first and second payments in respect of the LIFT program will be mailed to recipients before Christmas, as this affects many farmers in the west?

Hon. Otto E. Lang (Minister of Manpower and Immigration): No, Mr. Speaker, it is not likely that all of the final Lift program payments will be in the mail before Christmas. The office is processing these as quickly as possible but it will certainly be well into the month of January, according to the latest report, before they will be mailed.

Hon. Jack Davis (Minister of Fisheries and Forestry): Mr. Speaker, I am not sure whether this question involves legal opinion. However, I understand that the Criminal Code underlies certain clauses in the Canada Water Act. If that is so, the answer is yes.

If not, when does the minister feel this order can be lifted?

REGIONAL DEVELOPMENT INCENTIVES ACT

PROVISION OF SPECIAL DEVELOPMENT INCENTIVE, LOAN GUARANTEE, ETC.

The House resumed from Thursday, December 10, consideration of the motion of Mr. Marchand (Langelier) that Bill C-205, to amend the Regional Development Incentives Act, be read the second time and referred to the Standing Committee on Regional Development.

Mr. Jack Marshall (Humber-St. George's-St. Barbe): Mr. Speaker, I welcome the opportunity to comment on Bill C-205 because it has a particular effect on my province and especially on my district. I probably should have said that it could have had a particular effect on my district because so far, other than the odd dribble of funds—some \$11,000 to a firm to expand a vegetable packing plant, a grant to a hockey stick factory which was later not accepted, and a grant to establish a saw-mill operation—there has not been too much economic or employment advantage which I have seen.
