PENDING STRIKE OF WEST COAST MARINE PILOTS— POSSIBLE CHANGE IN TERMS OF REFERENCE OF PILOTAGE AUTHORITY TO MEET DEMANDS

Mr. James A. McGrath (St. John's East): Mr. Speaker, I should like to direct a question to the Minister of Transport. Has the minister met with representatives of the west coast pilots in view of the threat of a pending strike of British Columbia pilots with its national implications, and is he prepared to discuss with them changes in the terms of reference or guidelines for the west coast pilotage authority so that it will be able to meet the demands of the B.C. pilots?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, I received this morning a request from the pilots' association asking me to meet them. My hon. colleague was kind enough to give me notice of his question. I can only review the whole case to ensure whether my intervention at this time really "unbalances" the bargaining power of the interested parties. If not, I will happily

receive not only the pilots but also the British Columbia Pilotage Authority.

"IRISH STARDUST" INCIDENT AT ALERT BAY

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, I should like to put a question to the Minister of Transport.

Can he tell us whether the *Irish Stardust* was under the control of a Canadian pilot at the time of the accident near Alert Bay at the end of January? If so, why did the captain allow him to proceed to Victoria, given the condition of the hull?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, I cannot remember whether the vessel was in the area where the services of a Canadian pilot are required. I am going to check and advise the hon. member tomorrow morning or tomorrow afternoon, if he agrees.

As for the ship, it could hardly be left where it stood. It had to be taken somewhere and that was to be Victoria. I believe damages were reduced to a minimum and I doubt that anyone can complain about the behaviour of the department in that instance.

Mr. Munro (Esquimalt-Saanich): A supplementary, Mr. Speaker.

Will the minister be in a position to report soon on the accident which occurred about two months ago?

Mr. Marchand (Langelier): Mr. Speaker, I believe I have received just about all the details. We know exactly how much cleaning operations will cost. It is simply a matter of knowing what the company in question and what the government will pay and that I can tell the hon. member when I answer his question about the pilot.

Mr. Speaker: I doubt that the question of the hon. member for Esquimalt-Saanich is really supplementary to his previous question. Still, in a way, it could be related to the first question.
