Mr. MacLellan: The very least the Government could do would be to show some confidence in the industry and guarantee these loans. How many jobs have to be lost before the Government stops talking and takes some action?

Hon. Pat Carney (Minister of Energy, Mines and Resources): Mr. Speaker, the Government has taken action in the past which has generated more jobs in the oil patch than existed under the policies followed by the Party opposite when it was in government.

## LABOUR CONDITIONS

B.C. TELEPHONE COMPANY LAY-OFFS

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, my question is for the Minister of Employment. Is the Minister aware that in the Kootenay region of British Columbia, where unemployment has been 21 per cent, the B.C. Telephone Company will add to this tragedy by eliminating 70 jobs for telecommunication workers? Will the Minister approve the request of the Telecommunication Workers Union for a grant to study the impact of technological change, which is causing the women workers to be laid off in large numbers with no employment alternative in this area of very high unemployment?
