He showed that the government was not in a position to carry, and when his association with Mr. Burchill also led to that gentleman's defeat, it was reasonably hoped that, like Mr. Burchill, he would have consented to stand aside and allow the present vacancy to be filled by a gentleman of the same faith as the one who created it.
