INDIAN AFFAIRS

TRANSFER TO COMMISSION OF MATTERS UNDER JURISDICTION OF EXCHEQUER COURT

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, my question is to the Minister of Indian Affairs and Northern Development. Certain cases are now being started in the Exchequer Court which have been pending for years because the Indians had neither the money nor counsel to prove their claims in relation to treaties and other land rights. Will those cases now be transferred to the commission which the minister is setting up and will the Indians have counsel to enable them to set out their rights properly?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, there is nothing I can do about the Indians' own decisions. We will set up a commission to which they can, if they so desire, submit their representations. There will also be the sub-committee the Indians established in April which we trust will assist them in preparing the essential document to be presented on behalf of the Indians of Canada.
