

An Act respecting the Buffalo and Fort Erie Bridge Company.

**WHEREAS** the Buffalo and Fort Erie Bridge Company has, Preamble.  
 by its petition, prayed that it be enacted as hereinafter set forth, and it is expedient to grant the prayer of the said petition: Therefore Her Majesty, by and with the advice and 5 consent of the Senate and House of Commons of Canada, declares and enacts as follows:—

**1.** The Act to incorporate the Buffalo and Fort Erie Bridge 1891, c. 65,  
 Company, being chapter 65 of the statutes of 1891, and the 1893, c. 64,  
 Acts amending it, being chapter 64 of the statutes of 1893 and s. 1; and  
 10 chapter 70 of the statutes of 1895, are hereby revived and 1895, c. 70, s. 4  
 declared to be in force. revived.

**2.** The times limited by the said Acts for the commencement Time for  
 and completion of the undertaking of the Company are hereby construction  
 extended for two years and five years respectively from the of work  
 15 passing of this Act, otherwise the powers of construction extended.  
 conferred upon the Company by Parliament shall cease and  
 be null and void.

**3.** The section substituted for section 1 of chapter 65 of the 1891, c. 65,  
 statutes of 1891 by section 1 of chapter 64 of the statutes of new section 1.  
 20 1893, as amended by section 4 of chapter 70 of the statutes of 1893, c. 64,  
 1895, is hereby repealed, and the following is substituted s. 1;  
 therefor:— 1895, s. 70.

 amended by striking out the words “south of a point five  
 miles north of the village of Fort Erie,” and inserting in lieu  
 thereof the words “south of a point five miles north of the  
 36 International Bridge measured in a straight line therefrom.”

**5.** Section 3 of chapter 65 of the statutes of 1891 is hereby 1891, c. 65, s.  
 further amended by striking out in the twelfth and thirteenth 3 amended.  
 lines thereof the words “not exceeding six miles in length,”  
 and inserting instead thereof the words “within the said  
 40 county of Welland.”
