and a printed or written copy of so much of them as relate to or affect Certain Bylaws to be any party other than the members or servants of the Company, shall posted up. be affixed openly in all and every of the places where tolls are to be gathered, and in like manner as often as any change or alteration shall be made to the same; and the said Ey-laws and Orders so made and 5 published as aforesaid shall be binding upon and observed by all parties. and shall be sufficient in any Court of Law or Equity to justify all Certified copersons who shall act under the same; and any copy of the said Bypies to be evilaws, or any of them, certified as correct by the President, or some dence. person authorized by the Directors to give such certificate, and bearing 10 the common seal of the said Company, shall be deemed authentic, and shall be received as evidence of such By-laws in any Court without further proof.
