RE. Revision of Voters Lists.

" I was under the impression that we had not done very well because the work seemed to drag; but we find that 285 appeals were allowed as follows; Libs 233; Cons 52; Libs. added to list 124 names; Cons added 30 names; Libs struck off 109; the Cons struck off 22. ELGIN WEST August 8th, 1912.

Organizer W.H.Adams visited St. Thomas to-day and conferred with President C.St.Clair Leitch. Mr.Leitch stated that the lists are posted in Dunwich and Southwold Township, and Rodney Village.
