- COURSES IN CANADIAN HISTORY AND SOCIAL STUDIES SHOULD INCLUDE HISTORY, CULTURE AND CONTRIBUTION OF THE CANADIAN INDIAN ---- 313
- DROP OUT STUDENTS BE GIVEN SOME TECHNICAL TRAINING ---- 310, 311
- PRESENT SCHOOL CURRICULUM BE CHANGED WITH PARTICIPATION OF INDIANS -- 310
- SCHOOL TEACHERS ON RESERVES SHOULD HAVE UNDERSTANDING OF INDIAN CULTURE AND VALUES ---- 310
- INDIANS SHOULD DECIDE THEMSELVES ON INTEGRATION AND CENTRALIZATION OF SCHOOLS ---- 310
- REPLACE FOREIGN AND POOR QUALITY TEACHERS WITH CANADIAN TEACHERS -- 310

- EDUCATIONAL PROGRAMS ON ALCOHOL AND ITS EFFECTS FOR INDIAN YOUTH ---- 310
- METIS HAVE EQUAL RIGHTS AS INDIANS FOR EDUCATION AND MEDICAL SERVICES ---- 310, 394
- OPPOSED TO ANY CURTAILMENT OF MEDICAL HEALTH SERVICES TO INDIANS AND ESKIMOS ---- 299, 310
- MEDICAL SERVICES EXTENDED TO ISOLATED AREAS ---- 310
- DENTAL SERVICES PROVIDED ---- 310
- SHOULD BE INSTRUCTED ON TERMS AND EFFECTS OF VARIOUS MEDICAL PLANS AND GIVEN CHOICE OF ACCEPTING OR REJECTING THEM ---- 310
- MEDICAL SERVICES BE GIVEN BY DOCTORS OF ALBERTA AND NOT BY THE -CHIEFS- ---- 310
