BIG PROPERTY CHANGES HANDS.

Transfer of Richards Property.
American Con-
cern.

TO BUILD MILL.

Said Company Will Build at Chatham Next Year.

FREDERICTON, Jan. 16.—H. H. Gunter and R. W. McEwan, who have been in New York on business in connection with the transfer of the Richards property to the Miramichi Lumber Co., returned home last night by way of St. John.

They announce that the sale was completed several days ago and the new owners are now in charge of the property. The president and manager of the new company is John T. Rumble, and Charles E. Oak, of Bangor is vice president and treasurer. The stockholders are principally New York and Bangor capitalists.

It is understood that the price paid for the property is more than \$500,000. The new concern has acquired all the Richards Company's Miramichi property, including the mills at Boiestown and Chatham, but the old company retains the property on the Restigouche. Mr. Gunter will continue to act as president of the Richards Company. It is understood that the new company will erect, at Chatham, next season a large mill for the preparation of pulp wood for shipment to the American market.

The Miramichi Lumber Co., in addition to purchasing the Richards property, have, it is understood, acquired certain riparian fishing rights on the South West Miramichi belonging to Messrs. Charles W. and Harry Beckwith of this city and of the late Henry Phair. The purchase price is in the vicinity of \$2,500. The company are particularly interested in the fishing privileges, their object in making the purchase being to secure control of the shore rights for stream driving purposes.

TRACADIE LUMBER CO. WILL NOT REBUILD.

This Season's Cut to be Handled by Portable Mills—Other Properties May be Secured.

R. H. Wing, manager of the Tracadie Lumber Co., whose mills, together with a large quantity of sawn lumber were destroyed by fire a few weeks ago, was in the city yesterday. Mr. Wing says it is not the intention of the company to rebuild at Tracadie. The present winter's cut of logs will be manufactured by portable mills which have been secured. After that the company's operations at Tracadie will be suspended. Mr. Wing is at present looking at some other lumber properties with a view to purchasing. In the meantime the Tracadie property will not be decreasing in value. The news that this progressive firm have decided to discontinue operations at Tracadie will be heard with regret by the people of the village and vicinity, as employment was given to a very large number of men. WIFE WANTS PAY AS CLERK.

Surprises in Connection With W. C. Cumming Estate, Doaktown.

NEW CLAIMS.

Mrs. Cumming Presents Claim for \$5 a Week for Eight Years and Some Months.

At a meeting held in St. John last week in connection with the estate of William C. Cumming, merchant of Doaktown, Northumberland County, a surprise was furnished those present in the presentation of three more claims against the estate. The wife of the insolvent presented a claim for some \$2,400 for services as clerk in her husband's store. The claim is figured at \$5 a week for eight years, and some months, with deduction for holidays. A brother also presented a claim for \$2 a week for about the same period, but for what services was not stated. The time for filing claims will end tomorrow, but there came to the meeting a telephone message announcing that Mr. Swain of Doaktown, would present a claim for \$1,000.

These three claims, as said, came as a surprise for it was announced after the meeting that within the three months during which the estate has been under process of winding up, none of these interested had heard anything about these three claims. All three will be contested. At the meeting which was held in the office of H. H. Pickett, solicitor for the estate there were present besides Mr. Pickett, Sheriff O'Brien, of Northumberland County, assignee; W. S. Loggie, M. P. of Chatham; and J. M. Scovil and W. E. Foster, of St. John; inspectors of the estate.

The report of the assignee showed that the assets amounted to \$3,800, and the liabilities about \$7,000 in addition to the three new claims referred to. It was expected that at the meeting a dividend would be made, but on account of the new claims advertisement for six weeks was taken to contest them.

BOUND FROM ST. JOHN.

Norwegian Bark Cordillera Abandoned and set on Fire.

FREDERICTON, Jan. 15.—After five days continuous work at the pumps, Captain Carlsson of the Norwegian bark Cordillera, which left St. John, N. B. Dec. 25 for Buenos Ayres, was rescued at sea by the Norwegian steamship, Olaf Kyrre, which arrived today with Carlsson and his crew of eleven men. Dec. 27th the Cordillera sprung a leak and until January 1st the crew managed to keep the hole from filling rapidly, but on that day the vessel split in the middle and was in imminent danger of sinking. All hands were ordered to the pumps which were kept in constant operation until January 5, when the Olaf Kyrre rescued the men in an exhausted condition. They could not have kept the Cordillera afloat many hours longer. The Cordillera was set on fire.

PULP MILL'S NARROW ESCAPE.

Fire Discovered Sunday Morning Was Very Serious.

MILL CLOSED.

It Will be Some Time Before Repairs Can Be Made.

A serious fire occurred at the Dominion pulp mill on Sunday, by which several buildings were destroyed. These comprised the wood-pile, mill room and sulphur plant. The fire was discovered at about 8 o'clock in the morning and an alarm was sounded by the whistle of the factory, which was speeded upon the fire alarm in Chatham. Chatham citizens responded in large numbers and assisted the factory hands in the fierce fight they were making with the local appliances to subdue the flames, but it was found that the extent of the fire was such as to require additional help. Accordingly, Mr. Vickery, the manager, applied to Mr. or Nicol for some apparatus and the two steam fire engines were sent across with a contingent of firemen, who rendered valuable assistance in preventing the spread of the conflagration. It was a hard fight but at five o'clock the situation was saved and the fire under control, so the engines were brought back to town. It is not known how the fire occurred but the loss is a severe one, practically rendering the industry a total loss for some months at least.

There was eleven thousand dollars insurance on the mill plant, which was a total loss, and a thousand six hundred on the wood room which was a partial loss. The insurance was held on a schedule by various companies, including the Northern, Norwich Union, Western, Liverpool and London, Globe, North British, Mercantile, Guardian, Union, Mutual, Canadian, Phoenix of London, Theobald of Hartford, British American, Montreal, Canada, Commercial Union, Sun.

NEW WOODWORKING PLANT AT DALHOUSIE

The Restigouche Woodworking Co., Ltd. have recently completed an up-to-date woodworking plant at Dalhousie. The company was organized in February, 1906. The stockholders are chiefly prominent citizens of Restigouche county, including David Richards and Dow Sheels, lumbermen, of Campbellton and Richard O'Leary, a lumberman of Robbinston. W. S. Montgomery is president and general manager, J. E. Mercer vice-president, R. Y. Black, hall secretary, treasurer, G. L. Leveille of Montreal superintendent, while Dr. Richards and Alex. J. LeBlanc complete the board of directors. The location of the plant, in the best that could be found in Restigouche county, it consists of a whole square of the town of Dalhousie with streets on two sides the Intercolonial railway on one side and the Restigouche River on another side, with wharves adjoining for steamers and railways. The plant is said to be the most modern of its kind in New Brunswick, no expense having been spared to make it such.

STRATHCONA OPTIMISTIC

MONTREAL, Jan. 12.—Lord Strathcona, prior to leaving for New York, whence he will sail by steamer Carmania for England, delivered an address yesterday afternoon at the opening of the St. Lawrence Curling Club's new rink.

He took occasion to speak with great optimism of the future of Canada, predicting that by the end of the present century there would be a population in the Dominion twice as large as the combined populations of Great Britain and Ireland. Every thing was favorable towards that end, and the natural conditions of the country could scarcely be improved upon.

It was also satisfactory to know that the prosperity here, past and present, was due, not to a boom but to natural conditions.

He wished to be remembered by his friends not as Lord Strathcona, but as Donald Smith, the name of his one day's work in the Dominion.
