MOBILIZATION ACT—RECRUITMENT QUOTAS BY MILITARY DISTRICTS

Mr. PURDY:

On what basis are the quotas of recruits asked for from each military district under provisions of the National Resources Mobilization Act arrived at?

Mr. MITCHELL: The Department of Labour receive from the Department of National Defence (Army) requests to have men report to district depots and training centres in quotas based on training facilities. These are approximately in proportion to population. The mobilization section request the mobilization division in which the training centre or depot is situated to procure the men in question. However, the policy is to require all designated age groups in all divisions to be dealt with before designating and dealing with further age groups, and, if necessary, men mobilized in one division may be sent to other areas for training.

INVESTIGATION OF WAR INDUSTRIES BY MOUNTED POLICE

Mr. LACOMBE:

1. Since the beginning of the war, has the government issued any orders to the Royal Canadian Mounted Police to investigate the activities of certain war industries or those performing sub-contracts for same?

2. If so, (a) when, (b) what industries or private individuals, (c) with what results?

Mr. HOWE:

1. The Department of Munitions and Supply has not the power to issue any orders to the Royal Canadian Mounted Police. When circumstances warrant such action being taken as is suggested in the question, the department requests the Commissioner of the Royal [Mr. Gardiner.]

Canadian Mounted Police to institute investigations of such a character as are warranted by the circumstances.

- 6. What is the total amount of revenue which it is now estimated will be collected during the present fiscal year?
- 7. What has been the total increase in the net debt of Canada during each fiscal year since the outbreak of war?
- 8. What is it now estimated will be the total increase in the net debt of Canada at the end of the present fiscal year?
- 9. What was the total net debt of Canada on the following dates: March 31, 1914; March 31, 1919; March 31, 1930; March 31, 1939; March 31, 1940; March 31, 1941; March 31, 1942?
