## EXCISE TAX ACT

The House resumed from Tuesday, November 25, consideration in committee of Bill C-155, to amend the Excise Tax Act-Mr. Gray (for the Minister of Finance)-Mr. Faulkner in the chair.

The Chairman: Order, please. House again in committee of the whole on Bill C-155, to amend the Excise Tax Act. When the committee rose on Tuesday, November 25, 1969, clause 1 of the bill was being considered.

On clause 1-Definitions.

Mr. Gray: Mr. Chairman, yesterday evening when we were in committee the hon. member for Edmonton West made what I think is a very constructive suggestion as to our method of study of the bill before us. He drew to the attention of the committee the fact that clause 1 actually contains the major parts of the tax proposal in question. Clause 1 calls for the addition of a new Part II to the Excise Tax Act, and the new Part II is divided into a number of clauses. As I understand my hon. friend's proposal, it is that we deal with each of the clauses or paragraphs of the proposed new Part II in order and that we do not begin our discussion on any later clause or paragraph in Part II until we have concluded the discussion on the earlier paragraphs or clauses in question. I believe that is the procedure the committee used in the past when similar bills were being considered.

The Chairman: Is it agreed that we proceed in this way?

Some hon. Members: Agreed.

The Chairman: The discussion will begin on paragraph 8 (a)(1) of clause 1.
