SUGGESTED CHANGES IN CANADA PENSION PLAN AND INCOME TAX

Question No. 1,054-Mr. Mather:

- 1. Is consideration being given to the request of the Canadian Federation of Business & Professional Women's clubs that alleged discrimination against Canada Pension Plan contributors who die without leaving a spouse should be removed by providing a more equitable return of contributions to the deceased contributor's dependents or estate?
- 2. Is consideration being given for tax exemption for working women who must employ the services of others to maintain a home for themselves and their dependents?
- Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of National Health and Welfare and the Department of Finance as follows: 1. The Minister of National Health and Welfare is studying the brief submitted by the Canadian Federation of Business and Professional Women's clubs containing a resolution concerning survivorship pensions under the Canada Pension Plan as a part of the review of social security programs.

2. The Government proposes in paragraphs 2.7 and 2.8 of the White Paper on tax reform that a parent be allowed to deduct expenses incurred for child care up to a maximum of \$500 per child and not exceeding \$2,000 per family.
