or the other. I should like some indication. It is awfully cold out there and they really want to go home.

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, the men were out there last summer when it was very much warmer at a time when the government had offered them all jobs in the public service. I hope the hon. member will remember this, and perhaps talk to them and remind them of it. I can add, if the House is interested, that the subject has been under review by the government, and the Postmaster General is authorized to have a further discussion and make a final offer to them within the next few days.

## PENITENTIARIES

INCARCERATION OF YOUTHS CONVICTED OF NON-CAPITAL MURDER IN PRINCE ALBERT INSTITUTION RATHER THAN COMMON JAIL

Right Hon. J. G. Diefenbaker (Prince Albert): On a point of order, Mr. Speaker, yesterday I asked the Minister of Justice a question affecting the freedom and the rights of certain persons from Calgary who are in Prince Albert penitentiary pending the outcome of their appeal. The minister has been trying repeatedly to get your eye, and I understand the difficulty, but could there be an extension of the question period so he can answer?

Mr. Speaker: Order, please. The minister did get the eye of the Speaker but I was trying to accommodate as many hon. members as possible. The Minister of Justice has had his opportunity on a few occasions today to show his wisdom and knowledge, but if the House agrees, he might be allowed to reply to the question asked by the right hon. gentleman.

Some hon. Members: Agreed.

Hon. John N. Turner (Minister of Justice): Mr. Speaker, because of the point of order on which you ruled in favour of the hon. member for Cape Breton-East Richmond yesterday, I have not been able to bootleg in some answers today. However, in answer to the right hon. gentleman, I did get a report from the penitentiary service about a question he put to me yesterday. I am not satisfied with that answer, and I intend to communicate with the right hon. gentleman when I get an answer that satisfies me and, I hope, satisfies him.

Mr. Diefenbaker: Mr. Speaker, may I ask a supplementary question. Can the minister find out whether an arrangement was made between the government of Alberta and the government of Canada to allocate these prisoners to the Prince Albert penitentiary while they await the result of an appeal, which in my opinion is a totally callous and unjustifiable action?

UNEMPLOYMENT—REQUEST FOR STATEMENT BY MINISTER
OF MANPOWER AND IMMIGRATION ON
MEASURES TO BE TAKEN
