that the abortion law is being unevenly applied, partly as a result of congestion in certain metropolitan hospitals, is the minister studying any measures in conjunction with the provincial health ministers intended to ensure that this law is fairly applied regardless of whether people live in rural or urban communities?

Hon. John N. Turner (Minister of Justice): This is a matter we can properly deal with in debate. Of course, the administration of the law depends on enforcement by the provinces.

Mrs. Grace MacInnis (Vancouver-Kingsway): I wish to direct a supplementary question to the Minister of Justice, arising from his earlier answer to the effect that uneven facilities for abortion available in different hospitals could be considered in debate. I should like to ask the minister to do his best to see that we get an opportunity for such a debate during the present session.

### INDUSTRY

INCREASE IN PRICE OF CERTAIN SHIRTS BECAUSE OF IMPORT RESTRICTIONS

Mr. Steven E. Paproski (Edmonton Centre): Mr. Speaker, my question is for the Minister of Industry, Trade and Commerce. Has the government calculated what, if any, increase in the prices of work shirts and low and mediumpriced dress shirts will result, or has resulted, from the new import restrictions announced last month?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): The opinion of my experts is that the effect will be minimal if any. I would remind the hon. gentleman that there will still be a little more than 1.2 million dozen low priced shirts imported into Canada next year. I am quite sure the hon. member will be able to find one his size if he cares to.

Some hon. Members: Oh, oh!

Mr. Paproski: I do not think we should get personal, Mr. Speaker. May I ask whether the Prices and Incomes Commission was consulted in connection with the decision to limit imports of work shirts and low and medium-priced dress shirts?

Mr. Pepin: Not to my knowledge, Mr. Speaker but all departments were.
