# Question No. 1,934-Mr. Allard:

- 1. What is the present amount of the CNR debt?
- 2. What percentage is attributable to sources outside Canada?
- 3. What was the amount paid as interest since 1919, the year in which the Railway Act came into force?
- Hon. Jean Marchand (Minister of Transport): The Management of Canadian National advises: 1. Canadian National's long-term debt as at December 31, 1972 was as follows: Bonds, \$811,555,764; Government of Canada Loans, \$1,082,452,857; Total Long Term Debt. \$1,894,008,621.
- 2. The percentage of CN's long-term debt at December 31, 1972 which was raised in currencies other than Canadian dollars was 0.4 per cent.
- 3. The annual amounts of interest paid by Canadian National to the government of Canada; the interest on the funded and unfunded debt, and the amortization of discount on the funded debt are published by Statistics Canada in Catalogue 52-201 Canadian National Railways for each of the years 1923 to 1971 inclusive. The published

figures for 1971 were: Interest paid to government of Canada, \$42,740,982; Interest on funded and unfunded debt, \$47,030,552; Amortization of discount on funded debt, \$946,023.
