Further to his discussions with the Quebec authorities concerning the changes to be made in the special areas program, does the minister intend to make an announcement to the House that we might be made aware of the results of those talks?

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): As I have stated on a number of occasions, a federal-provincial work force is now discussing the papers and supplementary documents which I tabled on Friday. To date, no conclusions have been reached, but this is to be expected since the subject is a complex one. I hope to be able to say something definite on the result of these talks within a fortnight.

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): The situation is that the objective of our negotiations with the Province of Quebec and, indeed, with the other provinces, is to take advantage of economic opportunities regardless of where they happen to exist in a province rather than keeping within geographical dividing lines. In other words, there will be some changes in the so-called special areas or designated areas.

Mr. Grafftey: Mr. Speaker, I wish to ask a supplementary question.

Does the hon. minister intend to change his regional development policy before the end of this year?

Mr. Jamieson: Yes, Mr. Speaker. I have already indicated that this is the intention. We, of course, must have a federal-provincial agreement as the basis of our operations. So before anything could be announced specifically it would be necessary for it to be incorporated into a federal-provincial agreement. As I mentioned, I hope to secure at least a general developmental agreement with Quebec and some other provinces in the near future.
