**Mr. David Smith (Parliamentary Secretary to President of the Privy Council):** Madam Speaker, the following questions will be answered today: Nos. 2,652, 3,084 and 3,558.

**Question No. 2,652—Mr. Cossitt:**

1. Does a contract exist between Gerry McKee Associates and the Department of the Secretary of State and the Department of Communications and, if so (a) is the contract in the amount of \$23,000 plus travelling expenses (b) what are all the details, including whether the contract is renewable and whether a renewal contract has already been drawn up or is under discussion?

2. Did the company receive the contract in any way as a consideration for the fact that Mr. McKee was the Liberal party candidate in the constituency of Leeds—Grenville in the 1979 and 1980 general elections?

**Mr. Jack Masters (Parliamentary Secretary to Minister of Communications):** In so far as the Department of Communications is concerned, the reply to the above question is as follows:

3. Were any purchases of Almaden made while Mr. Donald Marriott held the position of Director of Restaurants and Catering and, if so, what were the names of all the persons involved in such purchases either on behalf of the Centre or representing the winery?

**Mr. Jack Masters (Parliamentary Secretary to Minister of Communications):** I am informed by the National Arts Centre as follows:

1. The National Arts Centre serves a house wine, Almaden California Chablis, by the carafe.

2. Purchases of Almaden commenced September, 1980.

3. All wine is purchased by the centre from the Ontario Liquor Control Board. See reply to question No. 3,085 tabled this day.

**Question No. 3,558—Mr. Cossitt:**

Since the date the last question on the Order Paper on the subject of applications by Soviet diplomats for travel between the permitted limit of Ottawa was answered, what are the names of all further applicants, the dates involved and the duration of the trip, the places visited, the means of travel and the diplomatic rank?

**Hon. Mark MacGuigan (Secretary of State for External Affairs):** The answer to question No. 3,258, tabled this day, provides details of travel by Soviet diplomats outside the national capital region during the period June 26, 1981, to October 27, 1981. The attached list covers the period October 28, 1981, to December 16, 1981, giving the names and ranks of the diplomats, the dates involved, the durations of the trips, and the means of travel.
