Eric George Adams

Charged with conspiracy to commit an offence under the Official Secrets Act and acquitted on the 22nd day of October, 1946.

Charged with an offence under the Official Secrets Act and acquitted on the 7th day of November, 1946.

Agatha Chapman

Charged with conspiracy to commit an offence under the Official Secrets Act and acquitted on the 27th day of November, 1946.

Charged with conspiracy to commit an offence under the Official Secrets Act and acquitted on the 7th day of December, 1946.
