SERVICE AT BLUE WATER BRIDGE INTERNATIONAL CROSSING

## UNEMPLOYMENT INSURANCE

SITUATION OF NEWFOUNDLAND FISHERY WORKERS

Hon. William Rompkey (Grand Falls-White Bay-Labrador): Mr. Speaker, my question is for the Minister of Employment and Immigration. I hope her answer to this one is as good as her answer to the last question put to her. It also concerns a disastrous situation that affects workers. There is a complete failure in the inshore fishery in Newfoundland. The Minister knows that. She knows that 50 per cent of the plant workers and fishermen will not have enough to qualify for benefits this winter. What is she going to do? Is she prepared now to take measures that were taken before, and announce a special work program so that people will not have to be demeaned by welfare this winter?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, I say to the Hon. Member that we are well aware of this situation. We have been following that matter very carefully. We know of the water temperatures and the failure in some parts of the fishing industry this summer. My colleague, the Minister of Fisheries and Oceans, is monitoring the situation in an ongoing way. Let me say to the Hon. Member that it would be premature to announce action at this point before we have seen the results of the fall fishing season. That is why we are keeping a very close watch over the situation.

## REQUEST FOR WINTER WORKS PROGRAM

Hon. William Rompkey (Grand Falls-White Bay-Labrador): I would say to the Minister, Mr. Speaker, it is not the temperature of the water, it is the temperature of the fishermen I am concerned about. It is getting hotter. If we wait until the end of this season in November, it will be too late. We need money. We need it now. If the Minister waits, it will be too late. Will the Minister now announce a works program for this winter?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, the Hon. Member knows that we took action this past spring in light of the ice conditions. We did that as we evaluated what was happening on an ongoing basis. We are doing exactly the same thing now. We will be in a position to see how the fall fishing season produces.
