the round, which was in Fitz's favor.

Fighting on Even Terms. Round 7.—Jeff was a bit slow coming to the scratch and broke ground with a circle of the ring. Fitz tried right to head, landing his left on ribs and got away clean. Then Jeff endeavored to land a straight left to face, but was blocked neatly and received a left on ribs. Fitz was on the aggressive and sent a left far back. Fitz put a straight left to crowd Fitz to the ropes, but Fitz got away neatly. Then in a rapid mix-up both swung rights and lefts for the leading lightly. Jeff came back with a hard left on the body. Fitz endeavored to land a vicious swing with his left on the body, but Jeff came back with a blow on Fitz's head. Jeff then bored in a blow on Fitz's left to Fitz's face, staggering the champion to the ropes. Fitz, of any moment occurred during the remainder of the round, and as Fitz walked to his corner he snatched at his seconds. This was Jeff's round.

Beginning of the End. Round 9.—Both came up willingly, with Fitz the aggressor, but Jeff sent his left swing for the head and received a left on the body; then they clinched, and right on the body, both tried lefts at close quarters. Jeff landing twice. Fitz, still on the aggressive, went back and more with left on body. After another clinch, Jeff put two small left raps on the nose, which made Bob bleed again. Jeff then again for the head smartly with his left, hitting straight, and then with a backhand blow, coming in left in contact with Fitz's nose. Fitz failed to respond to these and clinched. Jeff threw a left over the heart with all his might, and had Fitz guessing when the bell rang. Jeff had decided the best of the round.

Round 10.—Jeff came up looking confident, and Fitz wore an earnest look on his face. The Californian was first to land a left, straight left on the body, bringing it up to the chest. Fitz drove his left knee to the side, and went wide of the mark, but caught the Californian's nose. A straight left from Jeff made Fitz's head wobble, and then with a left swing he landed on Fitz's back. QUARANTINED DOUKHOBORS.

Mr. Archer, of the English Emigration Committee, is Looking After Them.

SIXTEEN CASES OF SMALLPOX.

A Fatal Case of Inflammation of the Lungs—Everybody Getting Vaccinated.

Quebec, June 9.—Mr. H. P. Archer of the English Committee for the emigration of the 2248 Doukhobors who are at present quarantined at Grosse Ile, returned to town this morning from the island, where he had gone some days ago in order to meet the ship and accompany the immigrants on board to the city. He left Grosse Ile last evening and crossed and took the Halifax express, which reached here this morning. He said that he had seen the ship with the immigrants in the distance, but that Dr. Montambert would not permit him to approach, but was, however, speaking to the doctor yesterday afternoon, and at that time there were some 16 cases of smallpox discovered and one case under observation. Two of the cases were among the crew. There was a fatal case of influenza, which was carried off by the arrival of the vessel at the island, and the remains were interred at Grosse Ile. The passengers were being vaccinated as they disembarked the immigrants, with their personal baggage, carrying about 250 or 300 of them each trip. SIXTEEN CASES OF SMALLPOX.

A Fatal Case of Inflammation of the Lungs—Everybody Getting Vaccinated.

Quebec, June 9.—Mr. H. P. Archer of the English Committee for the emigration of the 2248 Doukhobors who are at present quarantined at Grosse Ile, returned to town this morning from the island, where he had gone some days ago in order to meet the ship and accompany the immigrants on board to the city. He left Grosse Ile last evening and crossed and took the Halifax express, which reached here this morning. He said that he had seen the ship with the immigrants in the distance, but that Dr. Montambert would not permit him to approach, but was, however, speaking to the doctor yesterday afternoon, and at that time there were some 16 cases of smallpox discovered and one case under observation. Two of the cases were among the crew. There was a fatal case of influenza, which was carried off by the arrival of the vessel at the island, and the remains were interred at Grosse Ile. The passengers were being vaccinated as they disembarked the immigrants, with their personal baggage, carrying about 250 or 300 of them each trip.
