

17. *Resolved*, That a sum not exceeding Thirty-six thousand three hundred and twenty dollars be granted to Her Majesty, to defray expenses in connection with salaries and contingencies of Canal officers, for the year ending 30th June, 1883.

18. *Resolved*, That a sum not exceeding One million nine hundred thousand dollars be granted to Her Majesty, to defray expenses in connection with the Intercolonial Railway, for the year ending 30th June, 1883.

19. *Resolved*, That a sum not exceeding One hundred and ninety thousand dollars be granted to Her Majesty, to defray expenses in connection with the *Prince Edward Island* Railway, for the year ending 30th June, 1883.

20. *Resolved*, That a sum not exceeding Twenty thousand dollars be granted to Her Majesty, to defray expenses in connection with *Windsor Branch* Railway, for the year ending 30th June, 1883.

The first six Resolutions, being read a second time, were agreed to.

The Seventh Resolution, being read a second time, was postponed.

The next ten Resolutions, being read a second time, were agreed to.

The Eighteenth Resolution, being read a second time, was postponed.

The subsequent Resolutions, being read a second time, were agreed to.

Mr. *Kirkpatrick* reported from the Committee of Supply, several Resolutions; which were read, as follow:—

1. *Resolved*, That a sum not exceeding Sixty thousand dollars be granted to Her Majesty, to defray expenses connected with Geological Survey, for the year ending 30th June, 1883.

2. *Resolved*, That a sum not exceeding Twenty-five thousand six hundred dollars be granted to Her Majesty, to defray the following expenses in connection with Annual Grants to Indians:—For Indians of *Quebec*, \$4,200; for purchase of Blankets for aged and infirm Indians of *Ontario* and *Quebec*, \$1,600; for Indian Schools in *Ontario* and *Quebec*, *New Brunswick* and *Nova Scotia*, \$9,800; for Annuities under the *Robinson Treaty*, \$10,000, for the year ending 30th June, 1883.

3. *Resolved*, That a sum not exceeding Four thousand five hundred dollars be granted to Her Majesty, to defray expenses in connection with Indians of *Nova Scotia* generally, for the year ending 30th June, 1883.

4. *Resolved*, That a sum not exceeding Four thousand five hundred dollars be granted to Her Majesty, to defray expenses in connection with Indians of *New Brunswick* generally, for the year ending 30th June, 1883.

5. *Resolved*, That a sum not exceeding Two thousand dollars be granted to Her Majesty, to defray expenses in connection with Indians of *Prince Edward Island* generally, for the year ending 30th June, 1883.

6. *Resolved*, That a sum not exceeding Forty-two thousand two hundred and nine dollars and thirty-one cents be granted to Her Majesty, to defray expenses in connection with Indians in *British Columbia*: For Indians of *British Columbia* generally, \$23,300; Surveys, \$7,660; Reserve Commission, \$11,249.31, for the year ending 30th June, 1883.

7. *Resolved*, That a sum not exceeding Eight hundred and thirty thousand four hundred and ninety-nine dollars and thirty-nine cents be granted to Her Majesty, to defray the following expenses in connection with Indians in *Manitoba* and the *North-West*:—Annuities, \$197,445; Agricultural Implements, \$23,616.23; Tools, \$7,151.77; Cattle, \$11,200; Seed Grain, \$8,560; Ammunition and Twine, \$7,50; Provisions for Annuity Payments, \$43,440.07; Supplies for destitute Indians, \$291,525.20; Clothing under Treaties, \$5,500; Schools, \$23,668; Surveys, \$18,000; Farm Wages, \$48,540; Farm maintenance, \$39,903.12; Sioux, \$7,000; General Expenses, \$32,700; Commissioner's House and Office—Revote, \$12,000, for the year ending 30th June, 1883.

8. *Resolved*, That a sum not exceeding Four hundred and thirteen thousand dollars be granted to Her Majesty, to defray the following expenses in connection with the *North-West Mounted Police*:—Pay of Force, including Staff and extra pay to farmers, gardeners and artisans, \$160,000; Subsistence, \$70,000; Forage, \$50,000;
